NEWPORT ISLE OF WIGHT BOROUGH COUNCIL

The Newport Isle of Wight (Street Parking Places) Order No. 1 1973

Notice is hereby given that on 18th March 1974 the Newport Isle of Wight Borough Council made an Order under Sections 28 (1) and 31 (1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, with respect to street parking places in Quay Street, Newport, Isle of Wight.

The general effect of the Order is as follows:

- (1) to define the classes of vehicles which may use the parking places, the position in which they may park and the period for which they may park.
- (2) to forbid the use of any part of a parking place or any vehicle left in a parking place for sleeping or camping purposes, for eating or cooking purposes, for the purpose of servicing or washing any vehicle or part thereof other than is reasonably necessary to enable that vehicle to depart from the parking place, or for dismantling or breaking up any vehicle.
- (3) to require the stopping of the engine as soon as a vehicle is in position in a parking place and forbid the starting of the engine except when the position of the vehicle is to be changed or the vehicle is to depart from the parking place.
- (4) to forbid the use of a vehicle in a parking place in connection with the sale of any article to persons in or near the parking places or in connection with the selling or offering for hire of his skill or services.
- (5) to exempt certain classes of vehicles from any time limitation.
- (6) to make other incidental provisions.

- (a) To convert the restricted waiting restriction to an all-day prohibition of waiting on the length of the east side of Birley Street, Preston, extending for 20 metres northward from Harris Street and to exempt therefrom hackney carriages waiting there on a designated stand, and,
- (b) To exempt from waiting restrictions hackney carriages waiting between 6 p.m. and 6 a.m. following on a designated stand on the length of the east side of Lancaster Road, Preston, extending for 15 metres northward from Lord Street.

3. *The County Borough of Preston (Prohibition of Waiting—North Side of Tenterfield Street) Order 1974.*

GLOUCESTER CITY COUNCIL

The City of Gloucester (Longsmith Street) (Prohibition of Waiting) Order 1974

A further exception will also be provided for a vehicle in actual use for the purpose of delivering or collecting postal packets, as defined in Section 87 of the Post Office Act 1953.
- 3. A copy of the Order together with a plan showing the length of road referred to therein may be inspected at the Guildhall, Eastgate Street, Gloucester from Mondays to Fridays during normal office hours.

This Order shall come into operation on the 27th March 1974.
