

Subject to the exemption provided by virtue of section 11 (4) of the Act, if on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Area the occupier of that building shall be guilty of an offence, and liable to a fine not exceeding Twenty Pounds, unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity. There are no exemptions provided for in the Order itself.

If confirmed the Order will not come into operation before the 1st September 1975 or before a later date determined by the Secretary of State for the Environment.

After the operative date of the Order, any person who acquires any solid fuel other than an authorised fuel for use in a building, boiler or industrial plant in the Smoke Control Area, or sells, by retail for delivery by him or on his behalf to a building or to premises in which there is a boiler of industrial plant within the Smoke Control Area, will be liable on summary conviction to a fine not exceeding Twenty Pounds.

Copies of the Order and of the Map referred to therein may be inspected free of charge at the Council Offices, Parkgate near Rotherham between the hours of 9 a.m. to 5 p.m. on weekdays (excluding Saturdays) during the period of six weeks from the 29th March 1974.

Within the said period any person who will be affected by the Order may by notice in writing to the Secretary, Department of the Environment, 2 Marsham Street, London, SW1P 3EB, object to the confirmation of the Order.

THE SCHEDULE

An area of land at Monkwood within the Urban District of Rawmarsh defined by a line commencing with a point on the rear boundary of the property 80 Kent Avenue at which this declared Smoke Control Area reaches the area of the adjoining Smoke Control Area known as Monkwood Stage 2 Smoke Control Area, thence in a *southerly* direction along the rear boundaries of the even-numbered properties in Kent Avenue, as far as the *easterly* boundary of the property 8 Park Grove and the *eastern* extremity of Park Grove, then along the rear boundaries of the properties 7, 5 and 3 Park Grove in a *westerly* direction to the rear boundary of the property 47 Birchwood Avenue, thence in a *southerly* direction along the rear boundary of odd-numbered properties in Birchwood Avenue as far as Rosehill Road and its nearby junction with Birchwood Avenue, thence in a *southerly* direction along the centre-line of Birchwood Avenue to its junction with Monkwood Road, thence in a *north-westerly* direction along the centre-line of Monkwood Road as far as the *easterly* boundary of the property 45 Monkwood Road, and continuing in a *south-westerly* direction at the rear of the garages site and properties in Roman Crescent, and along the *easterly* boundary of the Kirklands Drive Estate, as far as the centre line of Haugh Road, thence in a *north-westerly* direction along the centre line of Haugh Road, as far as the property 101 Haugh Road, and continuing in a *north-westerly* direction along the centre-line of Haugh Road as far as a point opposite the property 44 Jackson Crescent, thence in a *northerly* direction at the rear of even-numbered properties in Jackson Crescent, as far as the centre-line of Monkwood Road, thence in *south-easterly* and *easterly* directions along such centre-line where this declared Smoke Control Area adjoins the declared Smoke Control Area known as Monkwood Stage 2 Smoke Control Area, and then following the boundary of such *adjoining* Smoke Control Area, at the rear of odd-numbered properties in Monkwood Road, as far as the rear boundary of the property 59 Monkwood Road, then in a *northerly* direction along the rear boundary of the properties 4 and 6 Kent Avenue, and the *westerly* boundaries of the properties 1 and 2 Warren Avenue, and of the properties 8 to 50 (even numbers) Kent Avenue thence in an *easterly* direction along the rear boundary of the properties 52 to 76 (even numbers) Kent Avenue, and then in a *south-easterly* direction along the rear boundary of the properties 78 and 80 Kent Avenue to the said commencing point.

CLEAN AIR ACT 1956

The Rawmarsh Urban District Council (Monkwood, Stage 2) (No. 1) Smoke Control Order 1974

Notice is hereby given that the Rawmarsh Urban District Council in exercise of the powers conferred upon them by section 11 of the Clean Air Act 1956 on the 27th February 1974 made an Order entitled *The Rawmarsh Urban District Council (Monkwood, Stage 2) (No. 1) Smoke Control Order 1974* declaring the area described in the Schedule hereto and shown coloured green and edged in red on the Map referred to in such Order to be a Smoke Control Area, which Order is about to be submitted to the Secretary of State for the Environment for confirmation.

An area of land at Monkwood within the Urban District of Rawmarsh defined by a line commencing with the *westerly* boundary of the property of 4 Woodleys Avenue, and then proceeding in a *north-easterly* direction along the rear boundaries of the properties Numbers 4, 6 and 8 Woodleys Avenue and then along the rear boundaries of the even-numbered properties in Rushey Close in an *easterly* direction as far as the *northerly* boundary of the property Number 3 Sharpfield Avenue then along the *northerly* boundary of the property Number 4 Sharpfield Avenue and the *westerly* boundary of the property Number 11 McManus Avenue, to the centre line of Hague Avenue and then along Hague Avenue in a *north-easterly* direction as far as its junction with Burkinshaw Avenue, then in a *south-easterly* direction along the centre line of Burkinshaw Avenue as far as its junction with Morris Avenue, then in a *southerly* direction along the *easterly* boundary of the property Number 46 Morris Avenue, and then along the *easterly* boundary of the Thorogate J.M.I. School land at the rear of the remaining odd-numbered properties in Burkinshaw Avenue, until such School land boundary meets the centre line of Thorogate, then in an *easterly* direction along the centre-line of Thorogate as far as the *easterly* boundary of the property 94 Thorogate, then in a *south-westerly* direction along the land boundary of Victoria Park, Rosehill, until this declared Smoke Control Area reaches, at the rear boundary of the property 10 Schoolfield Drive, the area of the adjoining Smoke Control Area known as Monkwood Stage 3 Smoke Control Area, then in a *north-westerly* direction along the rear boundary of the properties 10, 8 and 6 in Schoolfield Drive and then in a *westerly* direction along the rear boundaries of even-numbered properties in Thorogate as far as the property 22 Thorogate, then in a *southerly* direction to the *easterly* boundaries of the properties 3 and 4 Warren Avenue, then in a *north-westerly* direction along the rear boundary of even-numbered properties in Warren Avenue, as far as the property 32
