### Revised Map and Statement of Public Rights of Way in Draft Form

Notice is hereby given that in accordance with the provisions of section 33 of the National Parks and Access to the Countryside Act, 1949, as amended by section 31 of the Countryside Act, 1968, the County Council of the Administrative County of Cambridgeshire and Isle of Ely have:

(1) reviewed the particulars contained in the Revised Definitive Map and Statement for the former County of Cambridgeshire published on 19th February 1965 and in the Definitive Map and Statement for the former County of the Isle of Ely published on 8th September 1967;

(2) determined the date of this review as 1st February 1972.

This review is the Special Review being the first review begun by the County Council after the coming into force of the Countryside Act 1968. The review accordingly reclassifies, as either byways open to all traffic, bridleways or footpaths, ways:

- (a) which are shown as "roads used as public paths" in the above-mentioned Revised Definitive Map and Statement and the Definitive Map and Statement; or
- (b) which are shown as "bridleways" or as "footpaths" in the above-mentioned Revised Definitive Map and Statement and the Definitive Map and Statement and
