(Monday to Friday)*

7. *Meadow Lane.* From its junction with Holyoak Drive to its junction with Chatsworth Avenue on both sides of the road.

The Order also rescinds the existing ban on waiting at all times on the length of road on the south side of Northcote Street which extends from a point 27 yards west of 5 Northcote Street for a distance of 24 yards in a westerly direction.

A copy of the Order and map showing the roads to which the Order relates may be inspected at the Town Hall, Nottingham Road, Long Eaton, during normal office hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within 6 weeks from the 29th March 1974 apply to the High Court for this purpose.
