Bridge Road East (both sides) (i) From the east side of the Eastern Electricity Board sub-station footway crossing extending in an easterly direction to a point 15 metres east of the junction with Swallowfields and Ravenfield Road.

Swallowfields (both sides) (ii) From the junction with Bridge Road East in a northerly direction for a distance of 15

Ravenfield Road (both sides) (iii) From the junction with Bridge Road East in a southerly direction for a distance of 15 metres.

Exceptions in the Order permit vehicles to wait in these lengths of road for the purposes of:

(a) Picking up and setting down passengers

(b) Building operations and maintenance of the roads;

(c) The supply of gas, electricity or water;
 (d) The maintenance of Post Office services;

(e) Statutory powers or duties.

The Order will come into operation on 30th March 1974. Full details of these proposals are in the Order which, together with a map showing the restricted area, may be examined at the Clerk's Department, Council Offices, Welwyn Garden City, Hertfordshire, on Mondays to Fridays during existing office hours.

Any person who wishes to question the validity of the Order, or of any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or that any instrument made under it has not been complied with in relation to the Order, may within six weeks from the 26th March 1974, apply to the High Court for this purpose.

(c) To prohibit the waiting of vehicles (including for the purpose of loading and unloading goods) at any time on and in the sides and lengths of Egerton Street specified in the Second Schedule to this Notice

(d) To prohibit the waiting of vehicles between 8 a.m. and 6 p.m. on Mondays to Saturdays inclusive on and in the sides and lengths of Egerton Street specified in the Third Schedule to this Notice (except for the purpose of loading and unloading goods and certain other specified minor purposes).

The Order will come into operation on the 30th March 1974.

Exceptions in the Order will permit vehicles to be used in the lengths of roads referred to in this Notice for certain specified purposes including the maintenance of roads and to enable building and demolition operations to be carried out.
