

The area shown within the bold black line on the deposited plan which area comprises of the properties and warehouses bounded on the north-west by Church Bank, on the south-west by Well Street, on the south by Leeds Road to its junction with Chapel Street, on the south-east by Chapel Street, but includes numbers 30-40 (inclusive) of Chapel Street, and numbers 27-31 (inclusive) of East Parade. The area is bounded on the north-east by Peckover Street from its junction with East Parade to its junction with Church Bank, but excludes numbers 2-14 (inclusive) of Peckover Street and numbers 24-36 (inclusive) of Church Bank.

(c) *The Wool Exchange*

The area shown within the bold black line on the deposited plan which area comprises of the whole of Hustlergate, the north-eastern side of Queensgate, the whole of Kirkgate from its junction with Queensgate to Cheapside, and also includes numbers 19-23 (inclusive) on Cheapside. The area is bounded on the north-east by Cheapside from number 23 to its junction with Market Street, but includes the District Bank Chambers on the south-eastern side of Market Street. The area is bounded on the south-east by Market Street from its junction with Cheapside to its junction with Bank Street but includes the Midland Bank Chambers on the south-eastern side of Market Street. The area is bounded on the south-west by Bank Street from its junction with Market Street to Hustlergate and Queensgate, but also includes the property between Hustlergate and Tyrrel Street to its junction with Ivegate.

In accordance with section 277 of the Town and Country Planning Act 1971, notification of these designations will be sent to the Secretary of State for the Environment.

DEVELOPMENT ORDER 1973

DIRECTION UNDER ARTICLE 4

*Approximately 33.85 acres of land at Holder House, South Shields bounded on the north side by Nevinson Avenue on the west side by Soane Gardens on the east side by Holder House Way and on the south side by the Borough Boundary of South Shields.*

Notice is hereby given that the Council of the County Borough of South Shields did make on 29th March 1974 a Direction under Article 4 (3) (b) of the Town and Country Planning General Development Order 1973 relating to the above-mentioned land with respect to development described in Paragraph 1 Class II of the First Schedule to the said Order.

The effect of the Direction is that the permission granted under Article 3 of the said Order shall not apply to development within Paragraph 1 of Class II of the First Schedule to the said Order and therein described as follows:

The erection or construction of gates, fences, walls or other means of enclosure not exceeding 1 metre in height where abutting on a highway used by vehicular traffic, or 2 metres in height in any other case, and the maintenance, improvement or other alteration of any gates, fences, walls or other means of enclosure: so long as such improvement or alteration does not increase the height above the height appropriate for a new means of enclosure;

and the said development shall not be carried out on the said land unless permission is granted by the Local Planning Authority on an application made in that behalf.

A copy of the Direction and of the map defining the area of land to which the Direction relates may be inspected at the Town Hall, South Shields, at all reasonable hours.

The Direction will remain in force for 6 months from the 28th March 1974 and shall then expire unless it has, before the termination of the said 6 months, been approved by the Secretary of State for the Environment.

NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT 1971, SECTION 110

*Tadcaster Rural District Council (Lumby) Public Path Diversion Order 1973*

Notice is hereby given that on the 25th March 1974 the Tadcaster Rural District Council confirmed the above-named Order.

The effect of the Order as confirmed is to extinguish a length of footpath which commences 200 yards north of the junction of Butts Lane and Cass Lane, Lumby and extends for a distance of 133 yards, and create an alternative highway in lieu.

A copy of the confirmed Order and the map contained in it has been deposited at and may be inspected free of charge at the Council Offices, Station Road, Tadcaster, between 9 a.m. and 5 p.m. on weekdays (other than Saturdays).

This Order becomes operative as from the 25th March 1974 but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971, or on the ground that any requirement of that Act or any regulation
