The Stowmarket Urban District Council (Footpath No. 46) Public Path Diversion Order 1974

Notice is hereby given that the above-named Order, made on 25th March 1974, is about to be submitted to the Secretary of State for the Environment, for confirmation,

to to be confirmed as an unopposed Order, by the Mid Suffolk District Council.

The effect of the Order, if confirmed without modification, will be to divert the length of Public Footpath No. 46 in the Urban District of Stowmarket from a point outside No. 30 Edgcomb Road proceeding in a north-westerly direction for 30 yards, then in a south-westerly direction for 34 yards, then in a north-westerly direction for 50 yards (between Nos. 40 and 42 Edgcomb Road), then south-westerly for 10 yards and then north-westerly for 24 yards to the junction with Footpath No. 45, to a line running from a point outside No. 30 Edgcomb Road for a distance of 220 yards in a south-westerly direction (along the footway of Edgcomb Road), then in a north-westerly direction for 54 yards (along the footway on the northern side of Maltsters Walk), and then generally in a north-westerly direction for a further distance of 85 yards crossing Footpath No. 45 and terminating on the footway of Campion Crescent, Stowmarket.

A copy of the Order and the map contained in it has been deposited and may be inspected free of charge at the office of the Clerk of Stowmarket Urban District Council, Ipswich Road, Stowmarket, Suffolk, to 29th March 1974, and from 1st April 1974, at the Stowmarket Town Council Offices, 18 Bury Street, Stowmarket, Suffolk, during the normal office hours.

Any representation or objection with respect to the Order may be sent in writing to The Secretary, Mid Suffolk District Council, Council Offices, Castleton Way, Eye, Suffolk, not later than 3rd May 1974, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Mid Suffolk District Council, as successor authority to Stowmarket Urban District Council, may instead of submitting the Order to the Secretary of State for the Environment, themselves confirm the Order. If the Order is submitted to the Secretary of State any representations and objections which have been duly made and not withdrawn will be transmitted with the Order.
