### TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for the Environment hereby gives notice that he proposes to make an Order under section 211 of the above Act to authorise the stopping up of a length of Staverton Road, Daventry, in the interests of the safety of users of and to facilitate the movement of traffic on the Yeomanry Way which is a highway to be constructed in accordance with planning permission granted under Part III of that Act.

### TOWN AND COUNTRY PLANNING ACT 1971
