TENDERS FOR TREASURY BILLS

1. 6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the

Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

The Trunk Road (Victoria Road, Holyhead) (Bus Stops) (Clearway) Order 1974

Notice is hereby given that the Secretary of State for Wales intends to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

The purpose of the Order is to prohibit vehicles, other than buses, from waiting between 7 a.m. and 7 p.m. on any day at any bus stop in the length of road specified in the Schedule to this notice where the carriageway at that stop is marked (a) as a bus stop, and (b) with a broad yellow line adjacent to the edge of the carriageway ("the authorised markings").

Objections to the proposed Order should be sent to the Secretary of State, Welsh Office, Roads Division (Y Swyddfa Gymreig, Adran Ffyrdd), Graham Buildings, 139 Newport Road, Cardiff, CF2 1YU, by the 7th May 1974, quoting the reference number R15/221/5.

Although the Order includes every bus stop in the length of road specified in the said Schedule, it should be noted that the provisions of the Order which prohibit waiting will only apply to those bus stops which the Secretary of State marks with the authorised markings.

While the Order remains in force it enables the Secretary of State at any time to lay or remove the authorised markings at or from any bus stop in the specified length of road or to adjust the position in that length of road of the authorised markings as traffic conditions may require.

Other vehicles will be permitted to wait at the bus stops with authorised markings where necessary for:

1. The removal of an obstruction to traffic.
2. The maintenance of the road and in exercise of statutory powers with permission of a local authority, and
3. Reasons of emergency.

ROAD TRAFFIC REGULATION ACT 1967

The Trunk Road (Various Roads, Bakewell) (Prohibition and Restriction of Waiting) Order 1974

The Secretary of State for the Environment has made an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 on the London-Carlisle-Glasgow-Inverness Trunk Road (A.6).

The effect of the Order, which comes into operation on 10th April 1974 is to extend the prohibitions and restrictions already in force in Matlock Street, Rutland

Square and Mill Street so as to prohibit waiting between 9 a.m. and 6 p.m. in:

(1) Buxton Road from its northern junction with Back Mill Street for a distance of 215 yards in a north-westerly direction;

(2) Haddon Road

(a) from its junction with Matlock Street to a point 240 yards north-west of its junction with Wye Bank;

(b) on the south-west side from a point 240 yards north-west of its junction with Wye Bank to a point 220 yards south-west of that junction.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

Any person who desires to question the validity of, or of any provision contained in, the Order, on the ground that it is not within the powers with respect to the Order conferred by the above Act, or on the ground that any requirement of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order, may within 6 weeks of the 4th April 1974 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

ROAD TRAFFIC REGULATION ACT 1967

The Trunk Road (Hinckley Road, Kirby Muxloe and Braunstone) (Peak-Hour Urban Clearway) Order 1974

The Secretary of State for the Environment proposes to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, on the Birmingham-Great Yarmouth Trunk Road (A.47), known as Hinckley Road, part in the Parish of Kirby Muxloe and part in the Parish of Braunstone, in the District of Blaby, which extends from a point 22 yards east of its junction with Park Drive to its junction with the north-eastern side of Stafford Leys.

The effect of the Order will be to introduce a peak-hour urban clearway (i.e. waiting, loading/unloading of vehicles prohibited and picking up/setting down of passengers and personal luggage limited to 2 minutes) in the aforesaid length of road.

The clearway will operate between the hours of 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m.

Exceptions will be provided in the Order to enable a vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein. The severely disabled and blind persons will be exempt from the 2 minute waiting period indicated in paragraph 2.

A copy of the Order, together with a plan illustrating the proposal and a statement of reasons, may be inspected during office hours at the offices of the Leicestershire County Council at County Hall, Glenfield, Leicester and at the offices of the Blaby District Council, County Offices, Narborough, Leicestershire.

ROAD TRAFFIC REGULATION ACT 1967

The Trunk Road (Melton Road, West Bridgford) (Prohibition of U-Turns) Order 1974

The Secretary of State for the Environment proposes to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, on the Widmerpool-Nottingham-Bawtry-Goole-Howden Trunk Road (A.606), known as

Melton Road in the District of Rushcliffe, in the County of Nottingham

The effect of the Order will be to prohibit vehicles proceeding:

(a) north-westwards in the western carriageway of the trunk road to make a U-turn at a point 17 yards north-west of its junction with North Road, so as to proceed south-eastwards in the eastern carriageway of the trunk road; or

(b) south-eastwards in the eastern carriageway of the trunk road to make a U-turn at a point 15 yards south-east of its junction with North Road, so as to proceed north-westwards in the western carriageway of the trunk road.

BRIGHTON BOROUGH COUNCIL

The Brighton Corporation (School Lane) (One-way of Waiting) (No. 1) Order, 1974

The Brighton Corporation (School Lane) (One-way Traffic) Order 1974

Notice is hereby given that on the 29th March 1974 the Brighton County Borough Council made Orders under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is to:

1. Prohibit waiting at all times:
 - (a) in Chiltington Way and Tremola Avenue for 30 feet from their junctions with Lustrells Vale, Saltdean Drive for 135 feet from its junction with Lustrells Vale and in School Lane for 30 feet from its junction with Chiltington Way; and
 - (b) on the south-east side of Chiltington Way for a distance of 30 feet either side of School Lane; on the north-east side of Lustrells Vale for a distance of 45 feet either side of Chiltington Way and from a point 40 feet north-west to a point 59 feet south-east of School Lane and on the south-west side from a point 45 feet south-east of Saltdean Drive to a point 45 feet north-west of Tremola Avenue.
2. Require vehicles to travel in a north-westerly direction in that part of School Lane which was south-east to north-west.

The Orders will contain the usual provisions permitting vehicles to wait for persons to board or alight or goods to be loaded or unloaded or, if it is a Post Office vehicle for delivering or collecting postal packets; to enable the vehicle to be used in pursuance of statutory powers or duties or in connection with any building operation or demolition, the removal of any obstruction to traffic or the maintenance of the roads or the services therein, or in connection with bill posting, window cleaning or chimney sweeping.

Copies of the Orders, which will come into operation on the 2nd May 1974, and a map showing the part of roads affected may be inspected at the Enquiry Office at the Town Hall, Brighton, between the hours of 9 a.m. and 4.30 p.m. on Mondays to Fridays and between 9 a.m. and noon on Saturdays.

If you wish to question the validity of either of the Orders, or of any provision contained in them on the ground that they are not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or on the ground that any requirement of that Act or of any regulation made under it, has not been complied with in relation to the Orders, you may, within six weeks from the 29th March 1974 apply to the High Court for this purpose.
