*The Trunk Road (Holywell, Clwyd) (Restricted Roads and 40 m.p.h. Speed Limit) Order 1974*

Notice is hereby given that the Secretary of State for Wales intends to make an Order under section 72, 73, 74 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, prohibiting the driving of motor vehicles:
