INCREASES IN CHARGES FROM 1st MAY 1974

As from the issue of the London Gazette dated the 2nd May 1974, the rates for insertion of notices in certain classifications will be increased as follows;—

The Queen has been graciously pleased to give and grant unto John Philip Palmer Anderson, Lieutenant in the Kings Royal Hussars, of Little Harle Tower, Little Harle, Northumberland, who by Deed Poll dated the 23rd June 1973 assumed the surname of Anderson in lieu of that of Palmer, Her Majesty's Royal Licence and Authority that he may bear and use the Arms of Anderson and that the said Arms may be borne and used by his issue, the said Arms being first duly exemplified according to the Laws of Arms and recorded in Her Majesty's College of Arms, otherwise the said Royal Licence and Permission to be void and of none effect.

And to command that the said Royal Concession and Declaration be recorded in the said College of Arms.
