In the Parish of Horning

Lower Street

West side

The County of Norfolk (Holt) (Prohibition and Restriction of Waiting) Order 1974

Notice is hereby given that the Norfolk County Council propose to make an Order under the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be as follows:

1. Market Place (North side)

To revoke part of the existing limited waiting area in front of the Trustee Savings Bank and impose a waiting prohibition to protect the bus stop.

2. Market Place (South side)

To revoke the existing waiting restriction outside Messrs. Larners and to permit limited waiting of 60 minutes (Monday-Saturday 8 a.m.-6 p.m.).

Exceptions will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods and, where necessary, in connection with funerals, the maintenance of the roads and the supply of gas, electricity and water.

SOMERSET COUNTY COUNCIL

Somerset (Various Roads in Wellington) (Prohibition of Waiting) (No. 1) Order, 1974

Notice is hereby given that on the 3rd May 1974, the Somerset County Council made an Order under section 1

B 2

of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, the effect of which

(1) Prohibits waiting at any time on lengths of the following roads:

Waterloo Road B.3187.

North Street B.3187.

Victoria Street.

Court Drive.

(2) Prohibits loading and unloading between the hours of 8.30 a.m. and 9.30 a.m., and between the hours of 12 noon and 1.30 p.m., and between the hours of 3.30 p.m. and 4.30 p.m., on Mondays to Fridays inclusive, on the following lengths of road:

Waterloo Road B.3187.

North Street B.3187.

Exceptions have been made in the Order to enable a person to board or alight, or to enable a vehicle to be used in connection with any funeral, building operation or demolition, the removal of any obstruction to traffic, or the maintenance of the roads or services therein. Exemptions have also been made to enable goods to be loaded or unloaded from vehicles except for those lengths of road mentioned above during the prohibited peak hours.

The Order will come into operation on the 13th May 1974.

A copy of the Order, together with a map showing the lengths of road to which it relates, may be inspected at the office of the Chief Executive Officer, Taunton Deane District Council, Wellington Area Office, 35 Fore Street, Wellington, or at County Hall, Taunton, during normal office hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may within 6 weeks from the date of the making of the Order apply to the High Court for this purpose.
