(B) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle, except in designated parking places, between the hours of 11 a.m. and 6.30 p.m.:

(i) would be prohibited for a period of more than 20 minutes in the same place in the streets and certain lengths of street referred to in paragraph 6 (A) (i) (b) above on the days specified therein; (ii) would be varied so that the existing prohibition would apply in the lengths of street referred to in paragraph 6 (A) (ii) above on the days specified therein;

- (C) the sale or offer for sale of goods from a vehicle in the streets and certain lengths of streets referred to the streets and certain lengths of streets referred to in paragraph 6 (A) (i) above would be prohibited except on a Sunday, unless there is in force a valid licence issued by the Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;
- (D) the use of any vehicle or of any animal or the wearing of fancy dress or other costume wholly or mainly for the purpose of advertising in the streets and certain lengths of the streets referred to in paragraph 6 (A) (i) above would be prohibited.
