- 12. Candidates shall be admitted to the examination under such regulations as the Governing Body shall prescribe from time to time and the examination shall be conducted by such persons, in such manner, and at such times as the Governing Body shall from time to time direct.
- 13. Every Foundation Scholar from the date of his admission as a scholar shall receive such sum as the Governing Body may from time to time determine provided that the total amount awarded in any year shall not in any case exceed the amount of the full school fee.
- 14. There shall be selected in every year six Foundation Scholars who have been members of the School for not less than twelve months. Such selection shall be by the Governing Body on consideration of a report by the Head Master. Each of the Foundation Scholars so selected shall be termed a Senior Foundation Scholar and shall become entitled to receive a prize in the form of books to such value as the Governing Body may from time to time determine.
- 15. In each year two Foundation Scholarships shall be awarded to two boys at the School who have not already gained a Foundation Scholarship and who have been members of the School for not less than twelve months. These scholars shall be elected by the Governing Body on consideration of a report by the Head Master. The Governing Body may appoint either or both of the Foundation Scholars so selected, who are of sufficient merit, to be Senior Foundation Scholars. Each such Senior Foundation Scholar shall be entitled to the prize in the form of books provided by Statute 14 above.
- 16. The emoluments of all Foundation Scholars shall be paid, and may be withheld, suspended, or diminished according and subject to the provisions hereinafter contained and not otherwise.

#### Sutton's Prizes

17. The Governing Body shall in each year make provision for five Sutton's Prizes of such value and in such form as they shall from time to time decide. The Sutton's Prizes shall be awarded by the Governing Body on consideration of a report by the Head Master and shall be open to all boys in the School.

### General Provisions relating to Foundation Scholars

- 18. Every boy, on qualifying for election to a Foundation Scholarship shall be required forthwith to declare his readiness to accept such Scholarship upon the terms set forth in the Statutes and Regulations of the School for the time being. Tenure thereof shall be dependent on good conduct and diligence, to be from time to time certified to the Governing Body by the Head Master. If not already at the School, he shall be forthwith entered thereat, and shall receive no benefits from his Scholarship excepting for so long as he continues at the School.
- 19. Any or all of the Foundation Scholarships vacant in any given year may be withheld at the discretion of the Governing Body, in default of deserving candidates.
- 20. The Head Master shall have power to grant leave of absence to any Foundation Scholar for a period not exceeding one Term, but no Foundation Scholar shall be absent for more than one Term without leave from the Governing Body.
- 21. The Head Master shall have power to expel a Foundation Scholar or to suspend his Scholarship, and shall at once report to the Governing Body any such case of expulsion or suspension, and the reason thereof, and every such case shall be subject to an appeal to the Governing Body.
- 22. No Foundation Scholar shall be required to reside in a School Boarding House authorised by the Governing Body. Any Foundation Scholar who shall not reside in an authorised Boarding House shall be entitled to one half part only of his Scholarship during the time of his residence elsewhere but he shall not be entitled to any part of his Scholarship unless his place of residence be approved by the Head Master.
- 23. If a Foundation Scholar's work or conduct is considered by the Head Master to be unsatisfactory, he shall so report to the Governing Body at the next meeting. The Governing Body may, if they think fit, suspend such Foundation Scholar or deprive him of the whole or part of the emoluments of his Scholarship.

Musical Scholarships, Exhibitions, Bursaries and Grants in Aid

24. Subject to the making of financial provision for Foundation Scholars and for Sutton's Prizes as hereinbefore provided, any monies left at the disposal of the Governing Body may be applied by them for such general purposes of the School as the Governing Body may deem necessary. Such general purposes shall include the provision of musical scholarships or of exhibitions or bursaries or of grants in aid of the education of any boy or boys who may seem to the Governing Body to need and deserve such aid to enable them to enter or remain in the School, in such manner as the Governing Body may from time to time by regulation provide; provided that the total amount awarded to any boy in any year shall not in any case exceed the amount of the full school fee.

### Lady Holford's Trust Fund

25. The Trusts of the Will (dated the 19th day of November 1717) of Dame Elizabeth Holford are repealed and abrogated from the date of coming into operation of these Statutes in so far as they relate to and govern the Funds invested in the purchase in 1882 of Pageites (formerly Needwood House). From and after the abrogation of the said Trusts the said Funds shall be consolidated with the permanent endowment of the School and be held for the general purposes of the School.

## Bishop Benson's Trust Fund

26. The Trusts of the Will (dated the 29th day of June 1752) of Bishop Martin Benson are repealed and abrogated from the date of coming into operation of these Statutes in so far as they relate to and govern the Funds invested in the purchase in 1882 of Pageites (formerly Needwood House). From and after the abrogation of the said Trusts the said Funds shall be consolidated with the permanent endowment of the School and be held for the general purposes of the School. The Governing Body shall in each financial year commencing from the first day of September 1973 set aside a sum of not less than £51 which shall be applied by the Head Master in the purchase of School Prizes or in such other way, for the service of the School, as the Head Master shall think expedient.

### Bursar

27. The Governing Body may appoint a fit and proper person to act during their pleasure as Bursar, determine his duties and assign to him such remuneration, allowances, living accommodation, pension and otherwise as they shall think fit.

## Secretary

28. The Governing Body may appoint a fit and proper person to act during their pleasure as Secretary of the Governing Body, determine his duties and assign to him such remuneration, allowances, living accommodation, pension and otherwise as they shall think fit.

# Audit

29. The Governing Body shall appoint an Auditor. He shall be paid such fees as they shall think fit, and shall audit accounts and make a report in reference thereto at least once in each year.

## Common Seal

- 30. The Governing Body shall from time to time make rules for the safe custody of the Common Seal.
- 31. The Common Seal shall not be affixed to any writing or document except by the order of the Governing Body and in the presence of at least two members of the Governing Body.
- 32. A copy of every document or writing sealed with the Common Seal shall be entered in a Register to be kept for that purpose.

### Repeal of Existing Statutes

- 33. The foregoing Statutes shall take the place of the Statutes which were approved by His Majesty King George V in Council on the 16th day of December 1912 and subsequent amendments thereof but shall not operate to revive any of the Statutes and Regulations relating to Charterhouse School prior thereto or existing at the time of the passing of the "Public Schools Act 1868", which have been previously repealed."
- B. The Statute sealed on the 19th day of May 1917 relating to War Scholars shall be repealed.
