#### FIRCROFT ESTATES LIMITED (Dissolved) NOTICE OF DISCLAIMER

# under section 355 of the Companies Act 1948

#### WHEREAS:

1. Pursuant to section 355 of the Companies Act 1948 Fircroft Estates Limited (hereinafter called "the Com-pany") became dissolved in or about 1952.

2. It is alleged that immediately before such dissolution the property disclaimed by this Notice may have been vested in the Company and may by virtue of section 354 of the Companies Act 1948 be deemed to have become bona vacantia and to have vested in the Crown. 3. It is desired to disclaim the Crown's title (if any) to

the property.

4. The vesting of the property came to the notice of the Treasury Solicitor on the 18th April 1974. Now therefore I the Treasury Solicitor in exercise of the power in that behalf given by section 355 of the Com-panies Act 1948 Do by this Notice Disclaim the Crown's title (if any) to the property described in the Schedule hereto.

#### MISUSE OF DRUGS ACT 1971 SECTION 12 (2)

DIRECTION PROHIBITING EXERCISE OF POWERS IN RELATION TO CONTROLLED DRUGS

#### Gwynne Vaughan Lewis

In accordance with section 12(2) of the Misuse of Drugs Act 1971, notice is hereby given that the Secretary of State gave the following direction which was served and thereby came into effect on 29th April 1974:

Whereas Gwynne Vaughan Lewis, L.M.S.S.A., M.R.C.S., L.R.C.P., D.P.H., whose registered address is 63 Abbey Road, Beeston, Nottinghamshire, is a doctor who has been convicted of an offence under the Misuse of Drugs Act 1971:

Now therefore, in pursuance of section 12 (2) of the Misuse of Drugs Act 1971, I, The Rt. Hon. Roy Jenkins, one of Her Majesty's Principal Secretaries of State, by this direction prohibit the said Gwynne Vaughan Lewis from having in his possession, prescribing, administering, manufacturing, compounding and supplying and from authorising the administration and supply of the substances and products specified in the Schedule hereto and products specified in the Schedule hereto.

#### SCHEDULE

1. Amphetamine, dexamphetamine, methylamphetamine, methylphenidate and phenmetrazine.

2. Any stereoisomeric form of a substance specified in paragraph 1 above.

3. Any salt of a substance specified in paragraph 1 or 2 above.
