## WAGES COUNCIL

### WAGES COUNCILS ACT 1959

#### *Aerated Waters Wages Council (England and Wales)*

The Aerated Waters Wages Council (England and Wales) hereby gives notice of its intention to submit to the Secretary of State for Employment proposals for (1) increasing the statutory minimum remuneration set out in the Wages Regulation (Aerated Waters) (England and Wales) (Holidays) 1972 (Order A.(81)); (2) amending the provisions relating to holidays and holiday remuneration set out in the Wages Regulation (Aerated Waters) (England and Wales) (Holidays) Order 1972 (Order A.(82)); and (3) the revocation of Order A.(81) and Order A.(82).

Particulars of the proposals, which have been approved by the Pay Board, are contained in the Wages Council's Notice A.(83) which may be obtained on application to the Secretary of the Wages Council at the address given below.

The Wages Council will consider any written representation with respect to the above-mentioned proposals if made to it within 14 days from 31st May 1974. ### TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for the Environment hereby gives notice that he proposes to make an Order under section 209 of the above Act to authorise the stopping up of a length of passageway between Warrington Road and Grosvenor Road, Prescot, to enable development consisting of the erection of a factory extension to be carried out in accordance with planning permission granted to Cleggs of Prescot Ltd., under Part III of the said Act.
