NOTICE OF DISCLAIMER

Under Section 355 of the Companies Act, 1948

Whereas:

(1) Pursuant to Section 353 of the Companies Act 1948 Kaptan And Company Limited (hereinafter called "the Company") became dissolved on the 23rd January 1973.

(2) It is alleged that immediately before such dissolution the property disclaimed by this Notice was vested in the Company and may by virtue of Section 354 of the Companies Act 1948 be deemed to have become bona vacantia and to have vested in the Crown.

(3) It is desired to disclaim the Crown's title (if any) to the property.

(4) That the property may have vested came to the notice of the Treasury Solicitor on the 24th May 1974.

Now therefore I, the Treasury Solicitor, in exercise of the power in that behalf given by section 355 of the Companies Act 1948 do by this Notice disclaim the Crown's title (if any) to the property described in the Schedule hereto.

*The Trunk Road (High Street, Blaenau Ffestiniog)
(Prohibition of Waiting) Order, 1974*

Notice is hereby given that the Secretary of State for Wales has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, which shall come into operation on 20th June 1974, the effect of which will be to prohibit waiting in that length of road specified in the Schedule to this notice.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein; or to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties.

Copies of the Order may be obtained, free of charge, on application to the Secretary of State, Welsh Office, Roads Division (Y Swyddfa Gymreig, Adran Ffyrdd), Graham Buildings, 139 Newport Road, Cardiff, CF2 1YU quoting the reference R15/229/8.

If you wish to question the validity of the Order or any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may within 6 weeks of the 29th May 1974 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

SCHEDULE

That length of the Maentwrog-Betws-y-Coed-East of Conwy Trunk Road (A.470), known as High Street at Blaenau Ffestiniog in the County of Gwynedd, which extends from a point 75 yards north of its junction with Tabernacle Hill in a south-easterly direction for a distance of 360 yards.

*The Trunk Road (Inner Relief Road, Chepstow)
(Prohibition of Waiting) Order, 1974*

Notice is hereby given that the Secretary of State for Wales has made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which is to prohibit the waiting of vehicles at any time in the length of road specified in the Schedule to this notice.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein; or to enable the vehicle to be used in the service of a local authority in pursuance of statutory powers or duties.

If you wish to question the validity of the Order or any provision contained therein, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks of the 31st May 1974, apply to the High Court for the suspension of the quashing of the Order or of any provision contained therein.

SCHEDULE

That length of the London-Fishguard Trunk Road (A.48), (hereinafter in the Schedule referred to as "the trunk road") known as Chepstow Inner Relief, otherwise known as Upper Nelson Street, at Chepstow in the County of Gwent, which extends from its junction with that length of the trunk road known as Mount Pleasant in a north-easterly direction to its junction with that length of the trunk road known as Station Road.
