Notice is hereby given that by an Order made on Monday, the 25th day of March 1974 upon the petition of the above named Meadway Estates (Dunstable) Limited (hereinafter called the company) and of Rebecca Stanton of Branksome Dene Convalescent Home Alumhurst Road Bournemouth in the County of Hants a member of the company on the 25th February 1974 preferred unto this Court

And upon hearing Counsel for the petitioners and for the Registrar of Companies (the respondent)

And upon reading the said petition the affidavit of Selwyn Andrew Remington filed the 18th March 1974 the affidavit of Rebecca Stanton filed the 19th March 1974 and the exhibits in the said affidavits respectively referred to

And there being no opposition on behalf of Her Majesty to the relief sought by the said petition as appears from the said affidavit of Selwyn Andrew Remington and the exhibit thereto

And the petitioners by their Counsel undertaking within one month of the restoration of the name of the company to the register of companies to forward to the Registrar of Companies as required by section 124 and 126 of the above mentioned Act a copy of the annual return of the company for the year 1973 together with the documents annexed thereto as required by section 127 of the said Act: to give to the Registrar of Companies as required by section 107 of the said Act notice of any change in the situation of the registered office of the company and to send to the Registrar of Companies in form no 9A in The Companies (Forms) Order 1949 as required by section 200 of the said Act a notification of any change among the directors of the company or in its secretary or in any of the particulars contained in its register of directors and secretaries specifying the date of the change and that unless within two months of the restoration of the name of the company to the register of companies the petitioners have taken all steps necessary for procuring that the company be placed in voluntary liquidation forthwith to forward to the Registrar of Companies as required by sections 124 and 126 a copy of the annual return of the company for each of the years 1964 to 1973 inclusive together with the documents annexed thereto as required by section 127 of the said Act

This Court doth order that the name of the above named Meadway Estates (Dunstable) Limited be restored to the register of companies

And it is ordered that an office copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the said Meadway Estates (Dunstable) Limited is thereupon to be deemed to have continued in existence as if its name had not be struck off

And it is ordered that the Registrar of Companies do advertise this Order in his official name in the *London Gazette*

And it is ordered that the petitioners the said Meadway Estates (Dunstable) Limited and Rebecca Stanton do pay to the Registrar of Companies his costs of the said petition such costs to be taxed on the common fund basis
