TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 23rd August 1974, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, and the National Loans Act, 1968, to the amount of £200,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, 100,000 or £250,000. They will be dated at the option of the Tenderer on any business day from Tuesday, the 27th August 1974, to Friday, the 30th August 1974, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills

required are to be dated, and the net amount per cent. (being a multiple of one new half-penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent on the same day as Tenders are received, to the person whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

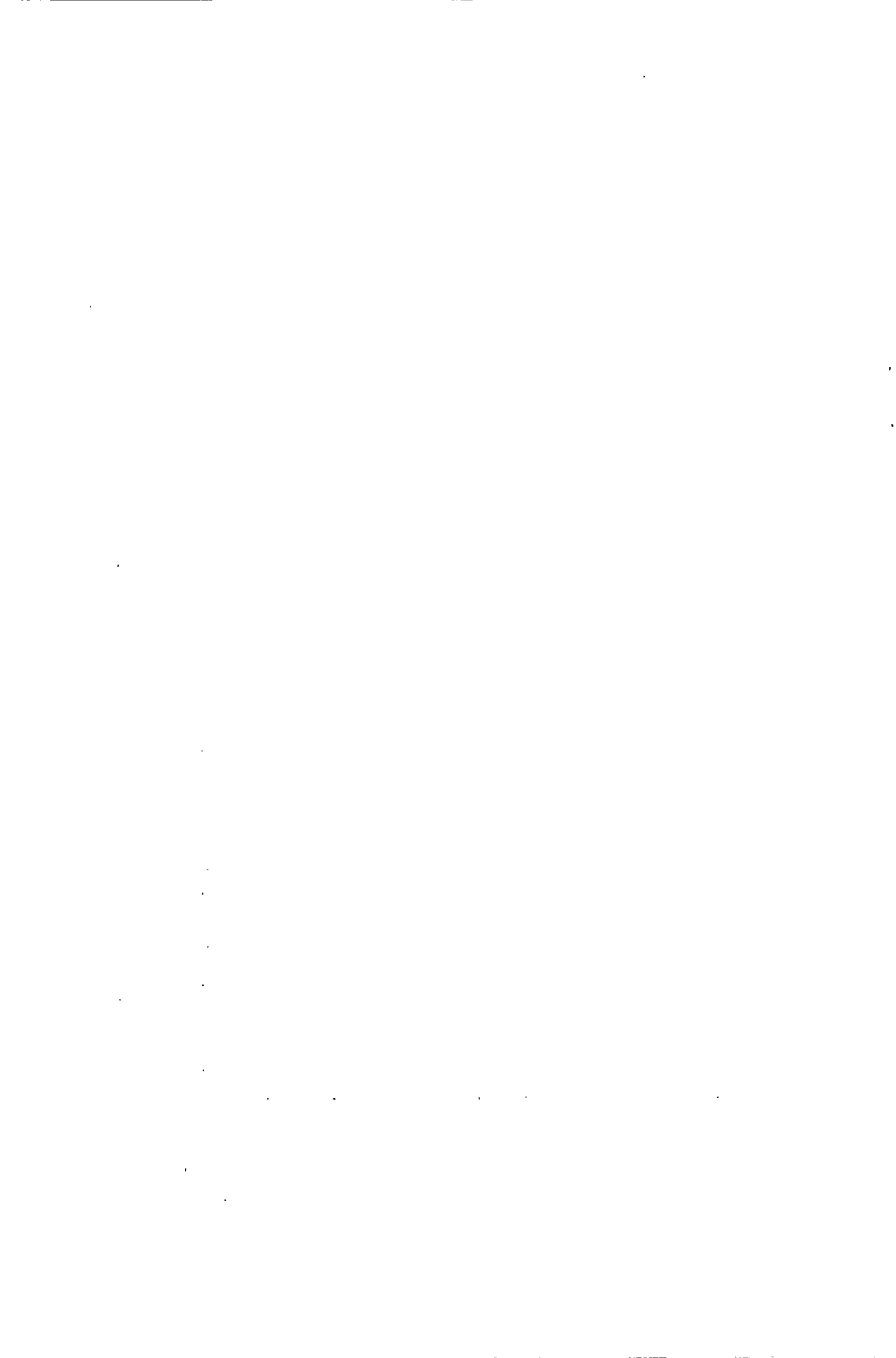

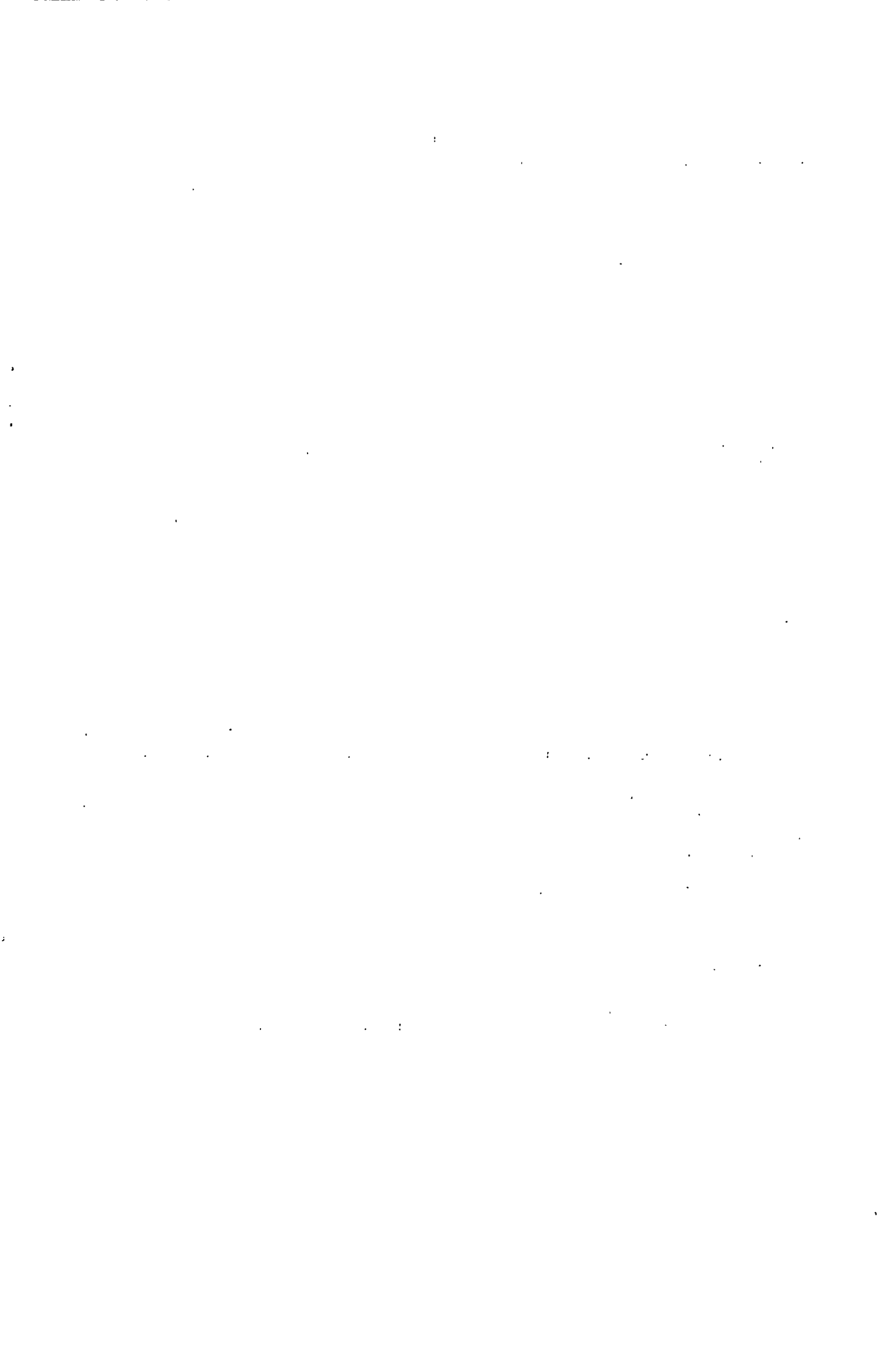

SCHEME T6/1974

NOTE: The Scheme which follows this Note has been made under Section 28 of the Post Office Act 1969 and will come into operation on 1st September 1974. It amends the Post Office International Telegram Scheme 1973 (Post Office Scheme T10/1973). The principal changes are:

- (i) certain detailed provisions concerning types of language admitted in telegrams and the counting of words which were prescribed in the principal Scheme are no longer so prescribed but fall to be determined under a general authority in the Scheme.
- (ii) certain services and facilities are withdrawn.

**THE POST OFFICE INTERNATIONAL TELEGRAM
AMENDMENT (No. 1) SCHEME 1974**

Made - - - - - 14th August 1974

Coming into operation - - - 1st September 1974

The Post Office, by virtue of the powers conferred upon it by section 28 of, and paragraph 3 (1) of Schedule 9 to, the Post Office Act 1969, and of all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement, Citation and Extent

1.—(1) This Scheme shall come into operation on the 1st day of September 1974 and may be cited as the Post Office International Telegram Amendment (No. 1) Scheme 1974.

(2) This Scheme shall extend to the United Kingdom and the Isle of Man.

Interpretation

2.—(1) This Scheme shall be read as one with the Post Office International Telegram Scheme 1973 (Post Office Scheme T10/1973), hereinafter called "the principal Scheme".

(2) In paragraph 3 (1) of the principal Scheme:

(a) the definitions of "European telegram" and "extra European telegram" shall be deleted;

(b) for the definition of "letter telegram" there shall be substituted:

"letter telegram" means a telegram accepted at a reduced rate on the conditions that it may be deferred in transmission or delivery or both and that it may be delivered by post, instead of by telegraph, and includes a ship letter telegram".

(c) for the definition of "plain language" there shall be substituted:

"plain language" means language consisting of words, figures or letters, combined into sentences or phrases conveying an intelligible meaning in one or more of the languages admitted for international telegraphic correspondence in plain language, each word and each expression having the meaning normally assigned to it in the language to which it belongs".

(d) after the definition of "urgent telegram" there shall be inserted:

"word" in relation to a rate of charge for the transmission of a telegram includes any letter, figure, or other symbol or any combination thereof which the Post Office may determine in accordance with paragraph 5 shall be reckoned as a chargeable word".

(3) The Interpretation Act 1889 applies for the interpretation of this Scheme as it applies for the interpretation of an Act of Parliament.

Revocation

3. Paragraphs 6, 7, 9, 10, 15, 16, 17, 23, 37 (4), 37 (5), 37 (6) and 38 (2) of the principal Scheme are hereby revoked.

Text

4. For paragraph 5 of the principal Scheme there shall be substituted:

" Text

5.—(1) The text of a telegram may consist of plain language or secret language or a combination of plain and secret language:

Provided that secret language shall be accepted for transmission only if the country for which the telegram is destined is willing to receive and deliver telegrams in secret language.

(2) A language shall be deemed to be admitted for international telegraph correspondence in plain language if and so long only as it is notified as such in the current appropriate publication of the General Secretariat of the International Telecommunication Union:

Provided that Latin and Esperanto shall be deemed to be so admitted without such notification.

(3) The Post Office may require the sender to produce evidence that any words or other expressions claimed to be in plain language are in plain language within the meaning of this Scheme.

(4) In the case of telegrams originating within the British Islands or transmitted over the first of their course from a mobile station to a land station within the British Islands, the Post Office may refuse to transmit the next or any part of the text which it considers to be unacceptable as plain or secret language."

Charges for Transmission

5. In paragraph 14 of the principal Scheme the following additional sub-paragraph shall be inserted:

"(3) For the purpose of calculating the amount or amounts payable in respect of the transmission of a telegram the chargeable number of words shall be reckoned in such manner as may be determined by the Post Office".

Services and Facilities—General

6. In paragraph 22 (6) of the principal Scheme the words in brackets "(except the indication GLT for which no charge is made)" shall be deleted.

Amendments to the Schedule

7. In the Schedule to the principal Scheme:

(a) for item 2 there shall be substituted:

" Letter telegram =LT= . . . 3)I(. . . 26, 28 and 38 "

(b) items 3 and 12 (c) shall be deleted.
