Parish boundary in Roffey Park, extending north-westwards for a distance of approximately 350 feet and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing at the public footpath (Path No. 1587), approximately 380 feet south of the southeastern end of the length of path to be stopped up, extending north-westwards for a distance of approximately 520 feet, thence north-eastwards for a distance of approximately 100 feet, to rejoin its original route at the north-western end of the length of path to be stopped up.

(22) Divert part of the public footpath (Path No. 1588), in the Parish of Lower Beeding, by stopping up the path commencing at its junction with the public footpath (Path No. 1587), in Roffey Park at the Lower Beeding-Horsham Rural Parish boundary, extending generally south-eastwards for a distance of approximately 720 feet, and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing on the public footpath (Path No. 1587), at a point approximately 550 feet south of the north-western end of the length of path to be stopped up, extending south-eastwards for a distance of approximately 720 feet, to rejoin the original route at the southeastern end of the length of path to be stopped up.

(23) Divert part of the public footpath (Path No. 1497), in the Parish of Rusper, by stopping up the path commencing at its junction with the public footpath (Path No. 1496), extending northwards for a distance of approximately 400 feet, and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing at the southern end of the length of path proposed to be stopped up, extending north-westwards for a distance of approximately 290 feet on a western headland, thence north-eastwards for a distance of approximately 180 feet on a northwestern headland to the northern end of the length of path to be stopped up.

(24) Divert part of the public footpath (Path No. 1497/1), in the Parish of Rusper, by stopping up the path commencing at its northern junction with the public footpath (Path No. 1497), extending south-westwards for a distance of approximately 200 feet and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing on the public footpath (Path No. 1497), 350 feet north-west of the northern end of the length of path to be stopped up, extending south-eastwards along a western headland for a distance of approximately 530 feet to the southern end of the length of path to be stopped up.

(25) Divert part of the public footpath (Path No. 1505), in the Parish of Rusper, by stopping up the path commencing at a point 50 feet west of its junction with the maintainable road at Burnt House Cottages, extending westwards for a distance of approximately 550 feet to a point 25 feet east of its junction with the maintainable road at its western end and substituting for that path a new length of public footpath a minimum width of 6 feet, commencing at the eastern end of the length of path to be stopped up, extending north-westwards for a distance of approximately 250 feet, thence south-westwards for a distance of approximately 400 feet all on a northern headland, to the western end of the length of path to be stopped up.

(26) Divert part of the public footpath (Path No. 1510), in the Parish of Rusper, by stopping up the path commencing at its junction with the public footpath (Path No. 1517), extending south-westwards for a distance of approximately 850 feet, thence north-westwards for a distance of approximately 300 feet and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing at the public footpath (Path No. 1517), 370 feet north-west of the eastern end of the length of path to be stopped up, north of the River Mole, extending south-westwards for a distance of approximately 550 feet on the northern side of the River Mole, thence northwards along a western headland for a distance of approximately 250 feet, thence westwards for a distance of approximately 30 feet to the western end of the length of path to be stopped up.

(27) Divert:

(a) part of the public footpath (Path No. 1517), in the Parish of Rusper, by stopping up the path commencing at its junction with the public footpath (Path No. 1510), extending south-westwards for a distance of approximately 150 feet; and

(b) part of the public footpath (Path No. 1510), in the Parish of Rusper, by stopping up the path commencing at its junction with the public footpath (Path No. 1517), extending north-eastwards for a distance of approximately 380 feet and substituting for those paths a new length of public footpath, a minimum width of 6 feet, commencing at the south-western end of the length of path (Path No. 1517), to be stopped up, extending northwards for a distance of approximately 110 feet, thence generally north-eastwards for a distance of the River Mole, thence southwards for a distance of approximately 40 feet to the north-eastern end of the length of path (No. 1510) to be stopped up.

(28) Divert part of the public footpath (Path No. 1513), in the Parish of Rusper, by stopping up the path commencing at its junction with Prestwood Lane, extending generally north-westwards for a distance of approximately 580 feet and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing at Prestwood Lane, approximately 600 feet north-west of the southwestern end of the length of path to be stopped up, extending north-eastwards on a south-eastern headland for a distance of approximately 430 feet to the north-western end of the length of path to be stopped up.

(29) Divert part of the public footpath (Path No. 1516), in the Parish of Rusper, commencing at its junction with the public footpath (Path No. 1512), extending northeastwards for a distance of approximately 590 feet and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing on the public footpath (Path No. 1512), 340 feet south-east of the southwestern end of the length of path to be stopped up, extending north-eastwards for a distance of approximately 640 feet along a farm track to the north-eastern end of the length of path to be stopped up.

(30) Divert part of the public footpath (Path No. 1487), in the Parish of Warnham, by stopping up the path commencing at a point 430 feet south-west of its junction with the railway line, extending westwards for a distance of approximately 560 feet and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing at the eastern end of the length of path to be stopped up, extending westwards along a woodland track for a distance of approximately 550 feet, thence southwards along an eastern headland for a distance of approximately 70 feet to the western end of the length of path to be stopped up.

(31) Divert part of the public footpath (Path No. 1380), in the Parish of Rudgwick, by stopping up the path commencing at a point approximately 1,950 feet south of its junction with public footpath (Path No. 1381), extending southwards for a distance of approximately 400 feet and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing at the northern end of the length of path proposed to be stopped up, extending south-westwards for a distance of approximately 200 feet, thence generally south-eastwards for a distance of approximately 230 feet to join the southern end of the length of path proposed to be stopped up.

(32) Divert part of the public footpath (Path No. 1384), in the Parish of Rudgwick, by stopping up the path commencing at a point approximately 430 feet north of its junction with the maintainable highway (A.281), extending generally north-wards for a distance of approximately 1,260 feet, thence north-eastwards for a distance of approximately 1,260 feet, thence north-eastwards for a distance of approximately 600 feet and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing at the southern end of the length of path proposed to be stopped up, extending north-eastwards for a distance of approximately 400 feet, thence north-westwards for a distance of approximately 150 feet, thence north-eastwards for a distance of approximately 280 feet, thence generally northwards for a distance of approximately 1,250 feet to join the northern end of the length of path proposed to be stopped up.

(33) Divert part of the public footpath (Path No. 1408), in the Parish of Rudgwick, commencing at a point approximately 125 feet north of its junction with the public footpath (Path No. 1407), extending generally southwards for a distance of approximately 350 feet and substituting for that path a new length of public footpath, a minimum width of 6 feet, commencing at the northern end of the length of path proposed to be stopped up, extending south-westwards for a distance of approximately 180 feet, thence southwards for a distance of approximately 150 feet, thence south-eastwards for a distance of approximately 150 feet to join the southern end of the length of path proposed to be stopped up.
