- 4. The Order would not apply:
- (a) to a vehicle being used under a road service licence whilst waiting at a place where it is authorised or required by that licence to pick up or set down passengers or to a vehicle being used to provide a London bus service, whilst picking up or setting down passengers; or
- (b) to a vehicle being used for fire brigade, ambulance or police purposes ; or
- (c) in certain circumstances, to a yehicle being used in the service of a local authority, in connection with building operations, etc., adjacent to the bus stop or the removal of an obstruction to traffic or the repair, etc., of the highway or of any service therein ; or
- (d) to a vehicle waiting for not more than 2 minutes to enable a person to board or alight or to load or unload his personal baggage. The limit of 2 minutes would not apply if the person has serious difficulty in walking or who is blind; or
- (e) where the person in control of the vehicle is required by law to stop or does so in order to avoid an accident.

5. The general effect of the Harrow (Waiting and Loading Restriction) (Amendment No.) Order 197 would be further to amend the Harrow (Waiting and Loading Restriction) Order 1971, so that in the lengths of streets specified in Schedule 2 to this notice

- (a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or un-loading a vehicle) would be prohibited between 8 a.m. and 6.30 p.m. Mondays to Saturdays inclusive;
- (b) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle would be prohibited:
 - (i) between 8 a.m. and 9.30 a.m. and between 4.30 p.m. and 6.30 p.m. on Mondays to Fridays inclusive; (ii) additionally for a period of more than 20 minutes
 - in the same place between:
 - (1) 11 a.m. and 4.30 p.m. on Mondays to Fridays inclusive ;
 - (2) 11 a.m. and 6.30 p.m. on Saturdays;
- (c) the sale or offer for sale of goods from a vehicle would be prohibited, except on a Sunday, unless there is in force a valid licence issued by the Harrow Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected ;
- (d) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising, would be prohibited.

6. The prohibitions referred to in paragraph 5(a) and (b)above would not apply in certain circumstances, e.g., the picking up or setting down of passengers ; the carrying out of statutory powers or duties; the taking in of petrol, etc., from roadside petrol stations; to licensed street traders, etc.

The prohibitions and requirements referred to in paragraphs 2(b)(i); (b)(iii) and (c), 3, 5(a) and (b) above would not apply in respect of anything done with the permission or at the direction of a police constable in uniform.

A copy of each of the proposed Orders, of the Harrow (Prescribed Routes) (No. 3) Traffic Order 1968, of the Harrow (Waiting and Loading Restriction) Order 1971 (and of the Orders which have amended that Order) and of the Council's statement of reasons for proposing to make the Orders can be inspected during normal office hours on Mondays to Fridays inclusive until 8th November 1974 in Room B21, The County Hall, London, SE1 7PB.

Notice is hereby given that the Greater London Council on 8th October 1974 made the above-mentioned Order under sections 6 and 84D of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act 1968.

The general effect of the Order will be further to amend the City of London (Waiting and Loading Restriction) Order 1972, so that in Hutton Street and Primrose Hill the hours during which the existing prohibition applies:

- (a) on waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be changed so that it will apply at any time of the day or hight throughout the week;
- (b) on waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place will be changed so that such waiting will be prohibited between 11 a.m. and 6.30 p.m. throughout the week.
