*The County of Wiltshire (Lengths of U/C Road No. 4089 and C.71 (Fosse Way) at Colerne Airfield) (Prohibition of Waiting) Order 1974.*

Notice is hereby given that the Wiltshire County Council propose to make an Order under section 1 of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, and Schedule 19 of the Local Government Act, 1972, the effect of which will be to prohibit waiting at any time on lengths of County road abutting Colerne Airfield as follows:

*Prohibition of Waiting at all times
