(d) Vehicles requiring access for essential loading and unloading purposes which as a general rule will only be allowed between the hours of 4 p.m. and 10.30 a.m.

Special provision will also be made in spaces designated for the parking of invalid carriages and vehicles displaying disabled persons badges immediately adjacent to the precinct

The reasons for the proposed Order are the creation of a pedestrian precinct with access for essential traffic and the Order should facilitate the passage on the roads of

the Order should facilitate the passage on the roads of pedestrians and preserve and improve the amenities of the area through which the roads run.
