- (d) Headland Promenade south from Fairy Cove, the Town Moor and peripheral housing including Beaconsfield Street, Beaconsfield Square, 7 & 9 Broadfield Road, Clarence Street, 99 to 131 Durham Street (odd numbers only), Friar Terrace, Gladstone Street, Henry Smith's Terrace, Lumley Square, Marine Crescent, Montague Street, Moor Parade, Nesham Road, Olive Street, Pentilly Street.

These areas, together with the existing Conservation Area, These areas, together with the existing Conservation Area, are defined on a plan which may be inspected free of charge at the offices of either the Borough Planning Officer, Hartlepool Borough Council, Villiers Street, Hartlepool, or the County Planning Officer, Cleveland County Council, Gurney House, Gurney Street, Middlesbrough.

The effect of designation is set out in the Town and Country Planning Act 1971 ("the 1971 Act") and in the Town and Country Amenities Act 1974 ("the 1974 Act") and attention is drawn particularly to the following provisions:

visions:

- Anyone wishing to demolish a building or part of a building within a Conservation Area must first apply for consent to the local planning authority in the same manner as if the building were listed as being a build-ing of special architectural or historic interest.
- Where any application for planning permission for development of land in or adjacent to the Conservation Area is made to the Hartlepool Borough Council and the development would, in the opinion of the Hartlepool Borough Council, affect the character or appearance of the Conservation Area, the application will be subject to the special procedure in Section 28 of the Town and Country Planning Act 1971 as amended.

Under the provisions of Section 101 of the 1971 Act as enacted in Section 5 of the 1974 Act anyone failing to maintain in a proper state of repair any unoccupied listed building, or in certain circumstances an unoccupied unlisted building in a Conservation Area is liable for any costs incurred by the local planning authority in carrying out urgent repairs under the terms of Section 101 of the 1971 Act.
