## DEPARTMENT OF THE ENVIRONMENT

### TOWN AND COUNTRY PLANNING ACT 1971

The Secretary of State for the Environment hereby gives notice that he has made an Order under section 209 of the above Act entitled "The Stopping Up of Highways (County of Devon) (No. SW1) Order 1975" authorising the stopping up of a length of Cattedown Road, Plymouth. Copies of the Order may be obtained, free of charge, on application to the Secretary of State, Froomsgate House, Rupert Street, Bristol, BS1 2QN (quoting DSW 505135/1/019), and may be inspected at all reasonable hours at the Offices of the Plymouth City Council, Municipal Offices, Royal Parade, Plymouth, PL1 2EW.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 22nd January 1975, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
