

HIGHWAYS ACTS 1959 TO 1971

The M.18 Rotherham—Goole Motorway (Wadworth to Armthorpe Section) and Connecting Roads Scheme 197 and

The M.18 Rotherham—Goole Motorway (Wadworth to Hatfield Section Side Roads) (Revocation) Order 197

The Secretary of State for the Environment hereby gives notice that he proposes to make the following Scheme and Order:

1. A Scheme under sections 11, 12, 14 and 286 of the Highways Act 1959, authorising him—

(a) to revoke in part the M.18 Rotherham—Goole Motorway (Wadworth to Hatfield Section) and Connecting Roads Scheme 1972 as follows:

(i) by excluding therefrom that length of the route of the special road authorised to be provided under that Scheme which starts at the termination of the M.18 Crick—Doncaster By-Pass Motorway at the roundabout over the A.1(M) at Wadworth and ends at a point on the northern boundary of Holme Wood Lane about 300 metres (328 yards) south-west of its junction with Thornham Lane in the Parish of Armthorpe, and

(ii) by deleting two special roads to connect the special road referred to above with the existing roundabout over the Doncaster By-Pass Special Road A.1(M) at Wadworth, and four special roads to connect the said special road with the proposed roundabout to be constructed at Doncaster Carr as part of the proposed Doncaster Carr Ling Road; and

(b) to provide for the exclusive use of traffic of Classes I and II of the classes of traffic set out in Schedule 4 to the Highways Act 1959 (as amended)—

(i) a special road at 11.4 kilometres (7.07 miles) in length along an altered route between the points described in paragraph 1(a)(i) above, and

(ii) two special roads to connect the above-mentioned special road with the roundabout over the Doncaster By-Pass Special Road A.1(M) at Wadworth,

all in the Borough of Doncaster in the County of South Yorkshire, and providing for the special roads referred to in paragraph 1(b) above to become trunk roads on the date when this Scheme comes into operation.

2. An Order under sections 13, 18 and 286 of the Highways Act 1959 which will authorise him to revoke the M.18 Rotherham—Goole Motorway (Wadworth to Hatfield Section Side Roads) Order 1972 which authorised the Secretary of State to:

(a) stop up a highway,

(b) construct a new highway, and

(c) stop up a private means of access to premises,

all on or in the vicinity of that part of the motorway route described in paragraph 1(a)(i) above which would have been situated at Doncaster Carr in the Borough of Doncaster.

Copies of the draft Scheme and Revocation Order together with the M.18 Rotherham—Goole Motorway (Wadworth to Hatfield Section) and Connecting Roads Scheme 1972 and all relevant plans may be inspected free of charge at all reasonable hours from 21st January 1975 to 23rd April 1975 at the Department of Environment, 2 Marsham Street, Westminster, London S.W.1, and at the offices of the Regional Controller (Roads and Transportation) Yorkshire and Humberside Region, 6th Floor, City House, New Station Street, Leeds; North Eastern Road Construction Unit, Block 8, Government Buildings, St. George's Road, Harrogate, North Yorkshire; South Yorkshire County Council, Regent Street, Barnsley; Doncaster Borough Council (Legal and Administrative Services Department), 4th Floor, Danum House, St. Sepulchre Gate, Doncaster and the Central Library, Waterdale, Doncaster; The County Library, Rossington Branch, McConnell Crescent, Rossington, Doncaster; The County Library, Armthorpe Branch, Church Street, Armthorpe, Doncaster; The County Library, Cantley Branch, Goodison Boul, Cantley, Doncaster; and the Post Offices, Branton, and Wadworth, Doncaster.

Proceedings on the above-mentioned draft Scheme and Revocation Order are being taken concurrently by virtue of section 14 of the Highways Act 1971.

Any person may not later than 23rd April 1975 object to the making of the above Scheme and Order, by notice to the Secretary of State at his address at the offices of the North Eastern Road Construction Unit, Block 8, Govern-

ment Buildings, St. George's Road, Harrogate, North Yorkshire quoting references CNE 418/1A/26/02 and CNE 418/1/26/04 and stating the grounds of objection.

THE IMPORTED FOOD REGULATIONS 1968, AS AMENDED

Belgium: Official Certificate

The Minister of Agriculture, Fisheries and Food gives notice that in exercise of the powers conferred on him by the Imported Food Regulations 1968 (S.I. 1968 No. 97), as amended by the Imported Food (Amendment) Regulations 1973 (S.I. 1973 No. 1351), he hereby restricts recognition of (1) the Official Certificate reproduced in the Schedule to the notice published in the *London Gazette* dated 15th June 1971, for the importation from Belgium of meat products and bacon and (2) the Official Certificates reproduced in the Schedules to the notices published in the *London Gazette* dated 31st August 1973, and 20th December 1973, for the importation from Belgium of meat (including bacon), to the extent shown in the Schedule hereto.
