

## COLCHESTER BOROUGH COUNCIL

*The Colchester Borough (Hawthorn Avenue, etc.)  
(Prohibition and Restriction of Waiting) Order 1975*

Notice is hereby given that the Colchester Borough Council, as agents for the Essex County Council, have made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which is:

- (a) to prohibit the waiting of vehicles at all times in the lengths of road specified in Schedule 1 to this notice; and
- (b) to prohibit the waiting of vehicles in the length of road specified in Schedule 2 to this notice between the hours of 8 a.m. and 6 p.m. on Mondays to Saturdays inclusive.

The Order does not prevent vehicles waiting for the purpose of loading or unloading goods, allowing passengers to board or alight or to enable works to be carried out in the road.

Any person who desires to question the validity of the Order or of any provision contained in the Order on the ground that it is not within the powers of the said section 1 or on the ground that any requirement of that section or of section 84A, 84B or 84C of the said Act or any regulations made under the said section 84C has not been complied with in relation to the Order may, within 6 weeks of the date on which the Order is made, make application to the High Court.

## SCHEDULE 1

*Lengths of Road in Colchester Borough*

*Hawthorn Avenue*, on both sides from a point 69 feet north of the centre line of its junction with Sycamore Road in a south-westerly direction to a point 65 feet south of the centre line of its junction with Acacia Avenue.

*Sycamore Road*, on both sides, for a distance of 45 feet from its junction with Hawthorn Avenue.

*Acacia Avenue*, on both sides, for a distance of 45 feet from its junction with Hawthorn Avenue.

## SCHEDULE 2

*Length of Road in Colchester Borough*

*Hawthorn Avenue*, on both sides, from a point 40 feet north of its junction with Solway Court in a south-westerly direction to a point 69 feet north of the centre line of its junction with Sycamore Road. (625)

*The Colchester Borough (Chapel Street, Rowhedge)  
(Prohibition of Through Traffic) Order 1975*

Notice is hereby given that the Colchester Borough Council, as agents for the Essex County Council, propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which will be that no person shall cause any vehicle to proceed in either direction along Chapel Street, Rowhedge, in the County of Essex, except for access to premises abutting Chapel Street.

## COLCHESTER BOROUGH COUNCIL

*The Colchester Borough (Trinity Street, etc.) (Prohibition of Through Traffic) Order 1975*

Notice is hereby given that the Colchester Borough Council, as Agents for the Essex County Council, propose to make an Order under section 1 of the Road Traffic Regulation Act, 1967, as amended, which will provide for the prohibition of traffic, except for access and servicing, from that

part of Culver Street from its closure westwards to the eastern car park entrance, the whole of Trinity Street and that part of Sir Isaac's Walk between Trinity Street and Shewell Road.

*The Colchester Borough (Cromwell Road, Portland Road and Shrubland Road) (Prohibition and Restriction of Waiting) Order 1975.**The Colchester Borough (Cromwell Road, Portland Road and Shrubland Road) (One-Way) Order 1975*

Notice is hereby given that the Colchester Borough Council, as Agents for the Essex County Council, propose to make Orders under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which will be:

- (a) To prohibit the waiting of vehicles at all times in the lengths of road specified in Schedule 1 to this Order;
- (b) To prohibit the waiting of vehicles between the hours of 8 a.m. and 6 p.m., Mondays to Saturdays inclusive, in the lengths of road specified in Schedule 2;
- (c) To restrict the waiting of vehicles to a period not exceeding two hours between the hours of 8 a.m. and 6 p.m., Mondays to Saturdays inclusive, in the lengths of road specified in Schedule 3; and
- (d) To prohibit the driving of vehicles in the road or lengths of road specified in Column 1 of Schedule 4 to this notice otherwise than in the direction specified opposite that road or lengths of road in Column 2 of that Schedule.

The Prohibition and Restriction of Waiting Order will not prevent vehicles waiting for the purpose of loading or unloading goods, allowing passengers to board or alight or to enable works to be carried out in the road.

A copy of the proposed Orders and a map showing the lengths of road to which the proposed Orders relate may be inspected at my office during normal office hours.

Objections to the proposals, together with the grounds on which they are made, must be sent in writing to the undersigned within 21 days from the date of publication of this notice.

## SCHEDULE 1

*In Colchester Borough*

*Cromwell Road*, on both sides from its junction with Mersea Road, eastwards for a distance of 45 feet.

*Cromwell Road*, on the north side from eastern junction with Portland Road, eastwards for a distance of 45 feet.

*Cromwell Road*, on the north side from its junction with Shrubland Road, westwards for a distance of 45 feet.

*Portland Road*, on the east side from its junction with Cromwell Road, northwards for a distance of 45 feet.

*Portland Road*, on the east side from its junction with Shrubland Road, southwards for a distance of 45 feet.

*Portland Road*, on the east side from a point 115 feet south of the northern end of the road, southwards to its junction with Shrubland Road.

*Portland Road*, on the east side from the northern end of the road, southwards for a distance of 67 feet.

*Portland Road*, on the west side from a point 241 feet north of its junction with Cromwell Road to the northern end of the road, including the turning head on that side of the road.

*Shrubland Road*, on the north side from its junction with Portland Road, eastwards to a point opposite the eastern boundary of No. 26 Shrubland Road.

*Shrubland Road*, on the west and south sides from a point 74 feet north of its junction with Cromwell Road, northwards and westwards to a point 173 feet east of its junction with Portland Road.
