Conservation Area at Wragby

Notice is hereby given that the Council of the City of Wakefield as District Planning Authority, after consultation with the West Yorkshire Metropolitan County Council have designated the area referred to in the Schedule to this notice as a Conservation Area for the purposes of section 1 of the Town and Country Amenities Act 1974. The designated area, which the District Council consider to be an area of special architectural or historic interest the character or appearance of which should be preserved or enhanced, will be the subject of stringent control of development and the District Council intend to take such action as may be available to them to secure the preservation and general improvement of the area.

The Conservation Area is more particularly defined on the map, which may be inspected free of charge, during normal office hours, at the office of the Chief Planning Officer, of the District Council Newton Bar, Wakefield or at the office of the Secretary to the District Council, Town Hall, Wakefield.

THE SCHEDULE

The Conservation Area covers the greater part of the village of Wragby.

The north-western boundary is marked by the boundary wall of Nostell Park; from here the boundary passes to the north of the garden of "The Lodge" and along the northern margins of the gardens associated with the houses to the north of the Doncaster Road, up to and including the Spread Eagle Public House.

From the southern corner of the Spread Eagle the boundary passes across the A.638 road to the south-eastern corner of the yard of Manor Farm and then along the rear boundaries of the properties to the south of the main road as far as Chapel Close. The boundary then passes along the western and northern edges of Chapel Close, and up the rear boundaries of the two cottages facing the War Memorial as far as the boundary wall of Nostell Park.

SCHEDULE

The land comprised in the application is situated in the Merthyr Tydfil Borough and the Rhymney Valley District in the county of Mid Glamorgan. The land is about 516 acres in extent, its centre being approximately 1 mile south-east of Dowlais Top and 2½ miles West of Rhymney. It is bounded on the North by the A465 Heads of the Valleys Road and on the North-West by the A4060 road. It lies on either side of the Dowlais/Fochriw Class III road and the North-Eastern part of the land forms part of the existing Royal Arms group of opencast sites.
