The Council of the County of North Yorkshire (Various Roads, Scarborough) (Prohibition of Waiting) (No. 1) Order, 1975, made under section 1 of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, and Schedule 19 to the Local Government Act, 1972, the effect of which is to prohibit the waiting of vehicles:

(a) at all times, on the lengths of roads specified in Schedule 1 to this notice;
(b) at all times from the 1st May to the 30th September (inclusive) in each year, on the lengths of roads specified in Schedule 2 to this notice.
