TOWN AND COUNTRY PLANNING ACT 1971

The highway to be stopped up is at Porthcawl in the Borough of Ogwr in the County of Mid-Glamorgan and is that length of the unnamed road leading from that length of road known as The Square to that length of road known as Eastern Promenade (A4106) which extends from a point 20 yards south of its junction with Eastern Promenade in a general northerly direction for a distance of 88 yards.
