

of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974, the effect of which will be to prohibit vehicles, the weight of which whether laden or unladen exceeds 5 tons from proceeding over Eastern Moor Bridge over Cripps River on the East Huntspill-Edington Burtle Road (Class 3) in the parish of East Huntspill.

This Order will come into operation on the 12th May 1975.

A copy of the Order together with a map showing the length of road affected may be inspected at the offices of the District Secretary and Chief Legal Adviser, Sedgemoor

District Council, The Priory, St. Mary Street, Bridgwater, or at County Hall, Taunton, during normal office hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act, or of any instrument made under it, has not been complied with in relation to the Order, you may, within 6 weeks from the 2nd May 1975, apply to the High Court for this purpose.

The London Borough of Sutton—Off-Street Parking

Notice is hereby given that the Council of the London Borough of Sutton proposes to make an Order under Sections 28(1) and 31 of the Road Traffic Regulation Act 1967 (as amended) the effect of which is to amend the London Borough of Sutton (Off-Street Parking Places) Order 1972 so as to increase the permitted times for heavy vehicles to use certain off-street parking places in the London Borough of Sutton, to remove from the car parking provided by the Council under the Road Traffic Regulation Act 1967 the underground car park at Meteor Way, Roundshaw, to restore thereto the car park at Worcester Road, Sutton, and to effect other minor and consequential amendments.

The Order will be called "The London Borough of Sutton (Off-Street Parking Places) (Amendment) Order 1975" and the time limits and classes of vehicle to which the proposed Order will relate are set out below.
