ROAD TRAFFIC REGULATION ACT 1967

The Trunk Road (Newbridge-on-Wye, Powys) (Restricted Roads) Order 1975

Notice is hereby given that the Secretary of State for Wales has made an Order, under section 72 (3), 73 (1) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, which shall come into operation on the 9th May 1975. The effect of the Order is that the length of road specified in the Schedule to this notice shall become subject to a speed limit of 30 miles per hour.
