Lengths of Highway to be Stopped Up (All distances are approximate)

The highways to be stopped up are at Cwm-y-Glo, in the County of Gwynedd. They are shown by zebra hatching on the deposited plan and are those lengths of the Caernarvon to Llanberis road (A4086), which extend

1. a point 7 yards west of the centre point of the bridge over the disused branch of the Llanberis Railway Line at the Railway Inn (now the Snowdon Public House) in a

westerly direction for a distance of 170 yards; and
2. a point 7 yards east of the centre point of the bridge over the disused branch of the Llanberis Railway Line at the Railway Inn (now the Snowdon Public House) in an easterly direction for a distance of 2 yards.
