- (1) Extinguish the public footpath (Path No. 2314) in the Parish of Pulborough commencing at the maintainable highway at Broomers Hill extending north-eastwards for a distance of approximately 850 feet to its junction with the public footpath (Path No. 2308/3).
- (2) Divert part of the public footpath (Path No. 1987) in the Parish of Pulborough by stopping up the path commencing at its junction with public footpath (Path No. 1983) extending generally north-eastwards for a distance of approximately 470 feet to its junction with the public footpath (Path No. 1988) and substituting for that path a new length of public footpath a minimum width of 6 feet commencing from a point on the public footpath (Path No. 1983) approximately 420 feet north of the south-western end of the length of path proposed to be stopped up extending generally south-eastwards for a distance of approximately 400 feet to the north-western end of the length of path proposed to be stopped up.
