

Minister of Agriculture, Fisheries and Food for an Order whereby, for the purposes of installing a set of mechanically operated gates at the entrance to Polperro Harbour and meeting their obligations and discharging their functions in the future and subject to the terms conditions and limitations set out in the draft Order hereinafter referred to, they will be enabled:

1. To borrow from time to time, upon the security of all or any revenues and property belonging to them and by any method or methods they see fit, such sums of money as they may think necessary not exceeding in aggregate £20,000, and with the consent of the Minister of Agriculture, Fisheries and Food such further sums of money as they may require.

2. To borrow temporarily, by way of overdraft or otherwise, such sums as they may require for meeting their obligations or discharging their functions under or in pursuance of any enactment, provided that the total amount outstanding at any one time of the money so borrowed shall not exceed £3,000.
