#### LIVERPOOL CITY COUNCIL

CLEAN AIR ACT 1956

The City Council of Liverpool No. 27 Smoke Control Order 1975

Notice is hereby given that the Liverpool City Council in exercise of the powers conferred on them by Section 11 of the above-mentioned Act on the 29th April 1975, made an Order entitled "The City Council of Liverpool No. 27 Smoke Control Order, 1975", declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Secretary of State for the Environment for confirmation.

Subject to the limitations and exemptions provided by the Order and by virtue of Section 11 (2) of the Act, if on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £20 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.
