Borough of Southend-on-Sea (Variation of Traffic Orders) Exemptions for Disabled Persons Order) 1975

Notice is hereby given that on the 19th May 1975 the Borough Council of Southend-on-Sea pursuant to arrangements made under section 101 of the Local Government Act 1972 with the County Council of Essex, in exercise of the powers of the said County Council under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with section 84C (1) of the Act of 1967 made the following Order, the effect of which will be that:

1. The Orders listed in the Schedule hereto being Orders which include a provision or apply a provision of an existing

Order which:

(i) prohibits the waiting of vehicles, or any class of vehicles, in a road or part of a road, except for the

purpose of loading or unloading, and

(ii) in relation to a particular vehicle would have the effect of prohibiting that vehicle from waiting in that road or that part of a road at all times in any day or during one or more specified periods in any day, and
(iii) is not a provision applying to a bus lane at a time
when the bus lane restriction is in operation, and

(iv) is not a provision to which paragraph (1) of Regulation 3 of the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1971 refers,

shall be varied by the inclusion therein of a provision permitting any disabled persons vehicle to wait in contravention of the prohibition included in or applied by the

(a) in a case where the period of the prohibition is of 2 hours' duration or less, for the whole of that period, and

(b) in a case where the period of the prohibition is of more than 2 hours' duration, for a period of 2 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle in the same road or part of a road on the same day)

provided that in relation to that vehicle the following requirements are satisfied, namely, that:

(i) in all cases a disabled person's badge is displayed in the relevant position on the vehicle, and
(ii) in the case mentioned in (b) above, a parking disc, issued by a local authority, complying with the requirements of the British Standard Specification for Parking Discs (B.S. No. 4631:1970) coloured orange, and capable of showing the quarter hour period during which a period of waiting begins, is displayed in a relevant position on the vehicle, and the driver, or other person in charge of the vehicle, marks on the parking disc the time at which the period of waiting has begun.

2. The Orders listed in the Schedule hereto shall be revoked to the extent that they contain any provision however expressed conferring on disabled persons' vehicles any exemption from any prohibition contained in any such Order to which Article 1 (i)-(iv) of this Order relates and which is inconsistent with the exemptions conferred by Article 1 of this Order.

3. This Order shall come into operation on the 1st June

Any person who desires to question the validity of the Order or any provision contained in the Order on the grounds that it is not within the powers of the relevant sections of the Road Traffic Regulation Act, 1967 as amended or on the grounds that any requirement of those sections or of section 84A, 84B or 84C of the Act, or any regulations made under the said section 84C has not been complied with in relation to the Order, may, within 6 weeks of the date on which the Order was made, make application for the purpose to the High Court.
