2. The effect of the Order will be:

(a) to prohibit vehicles proceeding in any road or length of road specified in column 1 of the Schedule to this notice from entering the road or length of road specified in relation thereto in column 2 of the said Schedule during the time between 9 p.m. on any one day and 6 a.m. on the following day,

The prohibition will not apply to vehicles being used

to provide a London bus service entering

(i) Liverpool Road from Holloway Road, Islington High Street or Upper Street, or

(ii) that length of Copenhagen Street which lies west of Barnsbury Road from Barnsbury Road or that length of Copenhagen Street which lies east of Barnsbury Road;

(b) to prohibit vehicles the overall width of which together with the load (if any) carried thereon exceeds 6 feet 6 inches from entering that length of Thornhill Road which lies between a point 90 feet north of the northern kerb line of Ripplevale Grove and a point 95 feet north of that kerb line.

3. Exemptions have been provided in the Order in respect of:

- (a) the prohibitions referred to in paragraph 2 (a) and (b) above in relation to vehicles being used for fire brigade, ambulance or police purposes in certain circumstances; and
- (b) the prohibition referred to in paragraph 2 (a) above, in respect of anything done with the permission or at the direction of a police constable in uniform.
- 4. The Order provides that in pursuance of section 9 (5) of the Road Traffic Regulation Act, 1967, the Chief Engineer (Traffic) or some other person authorised in that behalf by him may if it appears to him or that person essential in the interests of the expeditious, convenient and safe movement of traffic, modify or suspend the Order or any provision thereof.
