NOTICE OF APPLICATION FOR LICENCE TO ABSTRACT WATER

Notice is hereby given that an application is being made to the Welsh National Water Development Authority, Dee and Clwyd River Division, by the Wrexham and East Denbighshire Water Company, 21 Egerton Street, Wrexham, for a licence to abstract from an un-named tributary of the River Teirw 127,200 gallons per day near to the existing intake, National Grid Reference 177367, such quantity to be alternative to the water taken at the intake under the Company's Licence of Right.

A copy of the application may be inspected free-of-charge at the Company's offices at 21 Egerton Street, Wrexham, at all reasonable hours during the period beginning on Wednesday, 11th June 1975, and ending on Friday, 11th July 1975.

ROAD TRAFFIC ACTS

BOURNEMOUTH BOROUGH COUNCIL

The Borough of Bournemouth (Prohibition and Restriction of Waiting) Order 1975

Notice is hereby given that on the 9th June 1975, the Bournemouth Borough Council acting as agent of the Dorset County Council pursuant to arrangements made under section 101 of the Local Government Act 1972 with the said County Council, made the above-named Order under sections 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974. The new Order consolidates the provisions of the Orders specified in Schedules 1 and 2 to this Notice.

The effect of the new Order will be to revoke the Orders specified in Schedules 1 and 2 to this Notice, but the prohibitions and restrictions contained in those Orders will remain in force unchanged by virtue of the new Order.

Exceptions in the Order will permit waiting for the following purposes:

- (a) picking up or setting down passengers;
- (b) loading or unloading goods (except where such operations have been specifically prohibited);
- (c) carrying out essential services connected with the maintenance of the roads and the supply of gas, water and electricity.

The new Order also

- (i) confers on a traffic warden functions similar to those conferred by the Orders being consolidated, upon a police constable in uniform and
- (ii) permits a disabled person's vehicle to park for a maximum of 2 hours on those lengths of road where waiting has been prohibited or restricted (except during any period when loading and unloading has been prohibited on those lengths of road) subject to—
 - (a) the vehicle being driven by or being used for the conveyance of a disabled person;
 - (b) a disabled person's badge being displayed on the vehicle;
 - (c) a period of one hour having elapsed since the termination of a previous parking period on any particular road on the same day.

Full details are contained in the Order, a copy of which may be examined at the Town Clerk's Office, Town Hall, Bournemouth between 9 a.m. and 4.30 p.m. from Monday to Friday.

The Order will come into effect on the 30th June 1975.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from the 9th June 1975, apply to the High Court for this purpose.
