(iv) to stop up private means of access to premises; and

(v) to provide new means of access to premises;

- all between Chilton and Drayton in the county of Oxford, and
 - (b) to provide for the transfer of each of the said new highways to the County Council of Oxford as from the date on which he notifies that authority that the new highways have been completed and are open for through traffic.
