NOTICE OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT 1971—SECTION 210

LOCAL GOVERNMENT ACT 1972—SCHEDULE 16

The County of Mid Glamorgan (Community of Bridgend Footpath No. 2) Public Path Diversion Order, 1975

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order"), made on 23rd May 1975, is about to be submitted to the Secretary of State for Wales for confirmation or to be confirmed by the Mid Glamorgan County Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public right of way running across land situate in the Community of Bridgend and more particularly described in the Schedule annexed hereto.

A copy of the Order and the map contained in it has been deposited at the offices of the Clerk of the Ogwr Borough Council at:

- (i) Municipal Buildings, Queen Street, Bridgend, and
- (ii) Council Offices, "Greyfriars", Coity Road, Bridgend, and may be inspected free of charge, during normal office hours.

Any representation or objection with respect to the Order may be sent in writing to the County Clerk and Chief Executive, of the Mid Glamorgan County Council, Mid Glamorgan County Hall, Cathays Park, Cardiff CF1 3NE, not later than 26th July 1975, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn the Mid Glamorgan County Council may, instead of submitting the Order to the Secretary of State for Wales for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

SCHEDULE

PART I

Description of Site of Existing Paths or Ways

The highway to be diverted is in the Community of Bridgend in the Borough of Ogwr in the County of Mid Glamorgan, namely:

F.P. No. 2 in the Community of Bridgend that part from the eastern boundary of the disused Coity sidings railway in an easterly direction to a point 64 metres (70 yards) approximately north-west of Tremains House a distance of 500 metres (550 yards) or thereabouts.

PART II

Description of Site of Alternative Highways

A pedestrian way, from a point on the eastern boundary of the disused Coity Sidings railway, along the western, southern and eastern boundaries of "West Winds" then northerly and easterly to the Primary Road subways at Brackla Centre, then in a southerly direction to F.P. No. 2 at a point approximately 64 metres (70 yards) north-west of "Tremains House" a total distance of 809 metres (890 yards) or thereabouts shown on the deposited plan as a black broken line between points A and B.

TOWN AND COUNTRY PLANNING ACT, 1971, SECTION 210

The County of South Glamorgan (Barry Footpath No. 71) Public Path Diversion Order 1975

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 27th June 1975, is about to be submitted to the Secretary of State for Wales for confirmation or to be confirmed by the South Glamorgan County Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to divert the public right of way running across land situate at Little Coldbrook, Cadoxton, Barry, and more particularly described in the Schedule annexed hereto.

A copy of the Order and the map contained in it has been deposited at the offices of the County Solicitor, South Glamorgan County Council Headquarters, Newport Road, Cardiff, and at the offices of the Vale of Glamorgan Borough Council, Town Hall, Barry, and may be inspected free of charge during normal office hours.

Any representations or objections with respect to the Order may be sent in writing to the County Solicitor, South Glamorgan County Council Headquarters, Newport Road, Cardiff, not later than the 28th July 1975, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the South Glamorgan County Council, may instead of submitting the Order to the Secretary of State for Wales for confirmation, itself confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

SCHEDULE

PART I

Description of site of existing path

The footpath to be diverted is in Little Coldbrook, Cadoxton, Barry, in the county of South Glamorgan, namely:

That part of Footpath No. 71 from a point approximately 100 metres north of its junction with Sea View Terrace for a distance of approximately 225 metres in an easterly direction (F—P on deposited plan) then in a northerly direction for a distance of approximately 70 metres (P—A on deposited plan).

PART II

Description of site of alternative highway

That part of Footpath No. 71 from a point approximately 100 metres north of its junction with Sea View Terrace the path will proceed for a distance of approximately 55 metres in a northerly direction (F—G on deposited plan) then for a distance of approximately 95 metres in an easterly direction along Road F (G—H on deposited plan), then for a distance of approximately 50 metres along Road S in a southerly direction (H—J on deposited plan), then in an easterly direction along Road R for a distance of 70 metres (J—K on deposited plan) then in a northerly direction for a distance of 125 metres (K—M on deposited plan) then in an easterly direction for a distance of approximately 10 metres (M—N on deposited plan) then in a southerly direction for a distance of 30 metres (N—A on deposited plan).

County of Stafford (Footpath No. 11 Lichfield) Diversion Order, 1973

Notice is hereby given that on 23rd June 1975, the Staffordshire County Council confirmed the above-named Order.
