14. (c) (ii) the gratuity which he could have received on non-attributable invaliding except that an Officer with less than 2 years' qualifying service, including an officer with less than a 20 per cent. disability, may receive not less than half the 2 year rate of invaliding gratuity.

Section I

8. An officer who re-enters the Service within 5 years of being discharged on redundancy will be required to refund a portion of the Special Capital Payment awarded to him. The refund will be calculated as follows:

$$\frac{a-b}{a} \times \text{The Special Capital Payment}$$

(Where "a" = 5 years or his uncompleted period of service on redundancy, whichever is the less, and "b" = the break in service. In cases of "b" being greater than "a" there is no refund.)

Section III

38. Ratings who re-enter the service within 5 years of being discharged on redundancy will be required to refund a portion of the Special Capital Payment awarded to them. The refund will be calculated as follows:

$$\frac{a-b}{a} \times \text{The Special Capital Payment}$$

("a" representing 5 years, or the uncompleted period of service on redundancy, whichever is the less, and "b" the break in service.) This formula will produce a refund broadly as follows:

Break in Service	Refund of Special Capital Payment
1 year	4/5ths
2 years	3/5ths
3 years	2/5ths
4 years	1/5th
5 years and over	— (nil)

In addition to the above a discount of a period equal to that by which service on redundancy was enhanced will be made from any subsequent service reckonable for terminal benefits.

PRIVY COUNCIL OFFICE

THE PUBLIC SCHOOLS ACT 1868

THE GOVERNING BODY OF HARROW SCHOOL, having, on the 12th day of June 1975, in virtue of the powers conferred upon them by the above-named Act, made a Statute in the terms appended hereto amending Statute 4 of the existing Statutes of the said School, the said Statute is hereby published in the *London Gazette* in accordance with the provisions in that behalf contained in the said Act.

And notice is hereby given, that any person, body of persons or body corporate, authorised in that behalf by the said Act, may within two months after the publication of this notification petition Her Majesty in Council to withhold Her approval from the whole or any part of the said Statute.

STATUTE made by the Governing Body of Harrow School on the 12th day of June 1975

WHEREAS Statutes for the Government of Harrow School were made by the Governing Body of the said School under the Public Schools Act 1868 and approved and sealed by the Special Commissioners appointed for the purpose of the said Act on the 24th day of February 1874:

AND WHEREAS the said Governing Body in exercise of the powers for this purpose conferred upon them by section 11 of the said Act have resolved to alter Statute 4 of the said Statutes in manner hereinafter appearing:

BE IT ENACTED as follows:—

1. Paragraph 2 of Statute 4 (as altered by all subsequent alterations thereof hitherto enacted) relating to the fees

payable by each boy at the John Lyon School is hereby repealed.

2. In lieu of the said paragraph 2 of Statute 4 the following provisions shall henceforth form part of Statute 4 that is to say:

"2. The fees payable by each boy at the John Lyon School shall be such as the Governing Body, having regard to the financial requirements of the School, shall from time to time determine."

3. In all other respects Statute 4 of the above-mentioned Statutes shall remain in force.

TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office at the Bank of England on Friday, the 4th July 1975, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, and the National Loans Act, 1968, to the amount of £300,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000, £100,000 or £250,000. They will be dated at the option of the tenderer on any business day from Monday the 7th July 1975 to Friday the 11th July 1975 inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated and the net amount per cent. (being a multiple of one new halfpenny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part. Payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or by draft or cheque drawn on the Bank of England not later than 1.30 p.m. on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.
