The Borough of Rotherham (Malby Model Village) Public Path Stopping-up Order (No. 1) 1975

Notice is hereby given that on 2nd July 1975 the Rotherham Borough Council confirmed the above-named Order.

The effect of the Order as confirmed is to extinguish the public right of way across the "Band Stand" site in the centre of Malby Model Village running from a point opposite the junction of Queen Avenue with McClaren Crescent to a point opposite the junction of King Avenue with Deacon Crescent and from a point adjoining the junction of Earl Avenue, Deacon Crescent and McClaren Crescent to a point adjoining the junction of Duke Avenue, Deacon Crescent and McClaren Crescent.

A copy of the confirmed Order and the map contained in it has been deposited at and may be inspected free of charge at the Department of Legal and Administrative Services, Civic Building, Frederick Street, Rotherham, South Yorkshire, between 9 a.m. and 5 p.m. on Mondays to Fridays inclusive. The Order becomes operative as from 2nd July 1975 but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971, or on the ground that any requirement of that Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may under section 245 of the Town and Country Planning Act 1971 within 6 weeks from 2nd July 1975 make application for the purpose to the High Court.

SOMERSET COUNTY COUNCIL

Somerset (Footpaths Nos. 3/5, 3/8 and 3/18 at Gurney Slade, Binegar) Public Path Diversion Order, 1974

Notice is hereby given that on the 19th June 1975, the Secretary of State for the Environment confirmed the above named Order.

The effect of the Order as confirmed is to divert:

- (a) that part of footpath 3/5 at Gurney Slade, Binegar that runs from a point approximately 120 yards north-east of its junction with the Gurney Slade-Stratton on the Fosse County road in a north-easterly direction for a distance of approximately 733 yards;
- (b) that part of footpath 3/8 at Gurney Slade, Binegar that runs from a point approximately 330 yards east of its junction with the Bristol-Shepton Mallet A.37 County road in an easterly direction for approximately 97 yards to join footpath 3/5; and
- (c) that part of footpath 3/18 at Gurney Slade, Binegar that runs from its junction with the Gurney Slade-Stratton on the Fosse County Road in a generally north-westerly north-north-westerly and then westerly direction to its junction with footpaths 3/5 and 3/8, a total distance of approximately 657 yards. ...

The new routes to run:

- (a) from a point on the original route of footpath 3/5 at Gurney Slade, Binegar approximately 120 yards north-

east of its junction with the Gurney Slade-Stratton on the Fosse County road in a westerly and then generally north-north-westerly direction for a total distance of approximately 690 yards.

- (b) from a point on the original route of footpath 3/8 at Gurney Slade, Binegar approximately 330 yards east of its junction with the Bristol to Shepton Mallet A.37 County Road in a northerly direction for a distance of approximately 180 yards to joint footpath 3/7;

- (c) from a point on the Gurney Slade-Stratton on the Fosse County road at Gurney Slade, Binegar approximately 125 yards north-east of its original junction with footpath 3/18 in a westerly direction for a distance of approximately 50 yards, a generally northerly direction for a distance of approximately 170 yards, a westerly direction for a distance of approximately 50 yards, a northerly direction for a distance of approximately 250 yards and then in a generally north-westerly direction for a distance of approximately 407 yards to rejoin footpath 3/5 at a point approximately 50 yards north of its junction with footpath 3/7.

A copy of the confirmed Order and map contained in it has been deposited and may be inspected free of charge at the area office of Mendip District Council, Highfield House, Park Road, Shepton Mallet during normal office hours.

The Order becomes operative as from the date on which the Somerset County Council certify that the new paths have been created to their reasonable satisfaction but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town and Country Planning Act 1971, or on the ground that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may, under section 244 of the Town and Country Planning Act 1971, within six weeks from the 11th July 1975, make application for the purpose to the High Court.

STAFFORDSHIRE MOORLANDS DISTRICT COUNCIL

Town and Country Planning Act 1971, Section 210

Staffordshire Moorlands District (Footpaths Numbers 16 and 23)

Public Path Diversion Order, 1975

Notice is hereby given that the above-named order (hereinafter referred to as "the order") made on the 4th July 1975, is about to be submitted to the Minister of Housing and Local Government for confirmation or to be confirmed by the Staffordshire Moorlands District Council as an unopposed order.

The effect of the order, if confirmed without modification, will be to divert the public rights of way running from The Vicarage, Vicarage Road, Upper Tean to a point approximately 300 metres south-east of The Vicarage and running from a point on footpath number 23 approximately 150 metres south of its junction with Hollington Road to a point approximately 170 metres to the junction of footpath numbers 16 and 23 to a line running from The Vicarage, Vicarage Road south-eastwards for approximately 300 metres and to a line running from footpath number 23 diagonally across O.S. field number 4333 to footpath number 16 and thence south-eastwards for a distance of 150 metres, respectively.

A copy of the order and map contained in it has been deposited at New Stockwell House, Stockwell Street, Leek, Staffordshire, and may be inspected free of charge at The Secretary's Department, New Stockwell House, Stockwell Street, Leek, between the hours of 9 a.m. and 4.30 p.m. (excluding the period 1 p.m. to 2 p.m.) on Mondays to Fridays inclusive.

Any representation or objection with respect to the Order may be sent in writing to the Secretary, Staffordshire Moorlands District Council not later than 15th August 1975, and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the Staffordshire Moorlands District Council may, instead of submitting the Order to the Minister of Housing and Local Government for confirmation, themselves confirm the Order as an unopposed
