The Devon County Council (Various Streets, Torquay) (Prohibition and Limitation of Waiting) Order 1975

Notice is hereby given that on the 27th June 1975 the Devon County Council made an Order under sections 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended, varying and extending traffic restrictions at Torquay.

When the Order comes into effect on the 13th July 1975, you will not be allowed to leave your vehicle:

(a) at any time in the lengths of road specified in the First Schedule hereto;

(b) at any time from 1st May to 30th September each year in the lengths of road specified in the Second

The restrictions referred to in paragraph (d) and (e) above will not apply to disabled persons' vehicles.

There will be exceptions in the proposed Order to permit waiting for the purpose of:

(i) picking up and setting down passengers;

(ii) loading or unloading goods;

- (iii) collecting or delivering postal packets for the Post Office; taking in petrol, oil, water or air from a garage and, where necessary, in connection with-
- (iv) the maintenance of the road, and
- (vi) the supply of gas, electricity and water.

A copy of the Order, together with a map showing the affected roads, may be inspected during usual office hours, Monday to Friday, at the offices of Torbay Borough Council, Town Hall, Torquay, or at the address given below.
