NOTICE OF CONFIRMATION OF PUBLIC FOOTPATH ORDER

TOWN AND COUNTRY PLANNING ACT, 1971

Public Path (Codsall No. 4) Diversion Order 1975

Notice is hereby given that on the 15th July 1975 the South Staffordshire District Council confirmed the above-named Order.

The effect of the Order, as confirmed, is to divert that part of footpath No. 4 Codsall, running from a point "A" at the path's commencement in Bilbrook Road, Codsall, and running in a generally north-westerly direction for a distance of approximately 30 metres to a point "B"; to a line running from a point "C", approximately 10 metres west of the commencement of the existing footpath in Bilbrook Road at the aforementioned point "A", and running in a northerly direction for a distance of approximately 25 metres to rejoin the existing path at the aforementioned point "B".

A copy of the Order and map contained in it has been deposited and may be inspected free of charge at the Council Offices, Penkridge, Stafford, during normal office hours on Mondays to Fridays inclusive.

This Order becomes operative as from the 15th July 1975, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein, on the grounds that it is not within the powers of the Town and Country Planning Act, 1971, or on the grounds that any requirements of that Act or any regulation made thereunder has not been complied with in relation to the confirmation of the Order, he may under section 245 of the Town and Country Planning Act, 1971, within six weeks from the 25th July 1975, make application for the purpose to the High Court.

The Surrey County Council Public Path Diversion Order (No. 2) 1975 Right of Way Nos. 6, 7, 9 and 10

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on the 24th July 1975 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Surrey County Council as an unopposed Order.

The effect of the Order, if confirmed without modification, will be to direct those parts of public right of way Nos. 6, 7, 9 and 10 in the vicinity of Royal Mills, Esher, and land off Orchard Lane, West Molesey, to enable the works in connection with the River Mole flood alleviation scheme to be carried out which are shown in detail on the map attached to the Order.

A copy of the Order and maps contained in it has been deposited at, and may be inspected free of charge at, The Elmbridge Borough Council Offices, High Street, Esher, and the County Deeds Office, Room 119, County Hall, Kingston upon Thames, between the hours of 10 a.m. and 4 p.m. Mondays to Fridays inclusive.

If no representations or objections are duly made, or if any so made are withdrawn, the Surrey County Council may, instead of submitting the Order to the Secretary of State for the Environment for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for the Environment for confirmation, any representation and objections which have been duly made, and not withdrawn will be sent to the Secretary of State with the Order.

TOWN AND COUNTRY PLANNING ACT 1971, SECTION 210

West Sussex County Council (Burgess Hill) Public Path (No. 1) Diversion Order, 1975

Notice is hereby given that the above-named Order (hereinafter referred to as "the Order") made on 4th July 1975 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the West Sussex County Council, acting on behalf of the Mid-Sussex District Council, as an unopposed Order.

The effect of the Order if confirmed without modification will be to divert part of the public footpath (Path No. 1) in the Parish of Burgess Hill by stopping up the path commencing at a point approximately 350 feet east of its junction with public footpaths (Path Nos. 43 and 44) extending eastwards for a distance of approximately 730 feet and substituting for that path a new length of public footpath a minimum width of 6 feet commencing at the western end of the length of path proposed to be stopped up extending south-westwards for a distance of approximately 100 feet on a western headland thence south-eastwards for a distance of approximately 70 feet on a western headland thence generally eastwards for a distance of approximately 750 feet following the footway of a newly created estate road to join the western end of the recently diverted route of the path.

A copy of the Order and of the map contained in it has been deposited and may be inspected free of charge at the Office of the County Secretary, County Hall, Chichester, and at the Office of the District Administrator, Mid Sussex District Council, Oaklands Road, Haywards Heath, between 10 a.m. and 5 p.m. on Mondays to Fridays inclusive, and on Mondays to Saturdays at the Burgess Hill Branch Library, The Martlets, Burgess Hill between 10 a.m. and 7 p.m. Monday and Friday, 10 a.m. and 6 p.m. Tuesday, Wednesday and Thursday and 9.30 a.m. and 5 p.m. Saturday.

Any representations or objections with respect to the Order may be sent in writing to the County Secretary, County Hall, Chichester, Sussex, and should be received on or before 22nd August 1975 and should state the grounds on which it is made.
