#### WAKEFIELD CITY COUNCIL

TOWN AND COUNTRY AMENITIES ACT, 1974

*Conservation Areas at the Cathedral and Wood Street, Wakefield*

Notice is hereby given that the Council of the City of Wakefield, as District Planning Authority, after consultation with the West Yorkshire Metropolitan County Council, have designated the areas referred to in the Schedule to this notice as Conservation Areas for the purposes of section 1 of the Town and Country Amenities Act, 1974. The designated areas which the district council consider to be areas of special architectural or historic interest the character or appearance of which should be preserved or enhanced will be the subject of stringent control of development and the District Council intend to take such action as may be available to them to secure the preservation and general improvement of the areas. In particular, controls are applied to the demolition of buildings (owners are required to apply to the Council for listed building consent before carrying out works of demolition to any building or part of a building within the areas) and to the felling, topping and lopping of trees within the areas. Control may also be imposed in respect of the display of advertisements. There are penalties in the event of violation of this control.

The Conservation Areas are more particularly defined on the maps which may be inspected, free of charge, during normal office hours at the office of the Chief Planning Officer of the District Council, Newton Bar, Wakefield, or at the office of the Secretary to the District Council, Town Hall, Wakefield.

#### THE SCHEDULE

##### *The Cathedral Conservation Area, Wakefield*

The Conservation Area is in the centre of the city of Wakefield and is based around the Cathedral and the eastern end of Westgate. It adjoins the Westgate Conservation Area.

The boundary of the Conservation Area runs eastwards along Westgate and Kirkgate from Marygate to Teall Street.

It then runs up the centre of Teall Street and along the northern edge of the Cathedral grounds to Northgate. The boundary then runs northwards up the centre of Northgate to the Bull Ring. It then runs through the Bull Ring and along the centre of Marygate to Westgate.

##### *Wood Street Conservation Area, Wakefield*

The Conservation Area is based around the complex of municipal buildings along Wood Street in the centre of Wakefield.

It adjoins Wentworth Terrace Conservation Area to the north.

The boundary runs along the face of the West Yorkshire Constabulary Headquarters, so as to include the Constabulary War Memorial, and then between No. 10 Bond Street and the NALGO Staff Club. It then runs along Bell Street and Burton Street, along the side and rear boundaries of No. 3 Burton Street and between the County Hall Garage and No. 8 Cliff Parade. From there the boundary passes along Cliff Parade and Woolpack's Yard, and returns to King Street, including Nos. 47-49 King Street within the area. It then runs along King Street to Chancery Lane, between No. 18 Chancery Lane and No. 5 Crown Court, behind No. 1 Crown Court and back to Chancery Lane. It then passes up Chancery Lane and along Wood Street, between Nos. 38 and 40 Wood Street, then along the rear boundaries of the properties fronting Wood Street as far as the Health Offices. It then runs along Gill's Yard across Rishworth Street, and up Laburnum Road as far as the West Yorkshire Constabulary Headquarters.
