TOWN AND COUNTRY PLANNING ACT 1971

SCHEDULE

The highways to be stopped up are in the Borough of Wrexham Maelor. They are shown by zebra hatching on the deposited plan and are:

(1) That length of highway known as Wisteria Way, which extends from its junction with Lilac Way for its entire length, a distance of 153 yards.

(2) That length of highway known as Laburnum Way, which extends from its junction with Lilac Way for its entire length, a distance of 148 yards.

(3) That length of highway known as Jasmine Way, which extends from a point 35 yards south of its junction with Mold Road to its junction with Primrose Way and Lilac Way, a distance of 167 yards.

(4) That length of highway known as Lilac Way, which extends from its junction with Acacia Way in a general north-easterly direction for its entire length, a distance of 130 yards.

(5) That length of highway known as Primrose Way, which extends from its junction with Acacia Way in a general north-easterly direction for its entire length, a distance of 154 yards.

(6) That length of highway known as Acacia Way, which extends from its junction with Lilac Way in a general south-easterly direction for its entire length, a distance of 168 yards.
