Notice is hereby given that because of exceptional shortage of rain the Welsh National Water Development Authority, in respect of the Gwent Water Division, in pursuance of powers contained in section 1 of the Water Act, 1958, is applying to the Secretary of State for an Order as follows:

(a) Licence Serial No. 20/56/12/55 of the Water Resources Act 1963 provides that water can be abstracted from the Afon Lwyd river at Pontnewynydd at the rate of 1 million gallons per day providing that the flow in the Afon Lwyd at the Ponthir Weir is or is in excess of 27 cu. secs. The Authority seeks to reduce the said abstraction with a limiting river flow from 27 cu. secs. to 20 cu. secs. for a period of 3 months or until the flow is in excess of 27 cu. secs. whichever is some

of 3 months or until the flow is in excess of 2/ cu. secs. whichever is sooner.

(b) Licence Serial No. 20/56/34/18 of the Water Resources Act 1963 provides that the amount of compensation water discharged into the River Grwyne Fawr from the Grwyne Fawr reservoir shall be not less than 750,000 gallons per day. The Authority seeks to reduce the amount of compensation water to 250,000 gallons per day for a period of three months or until gallons per day for a period of three months or until such times as the Grwyne Fawr Reservoir is full whichever is the sooner.

(c) Licence Serial No. 20/56/64/63 of the Water Resources Act 1963 provides that the amount of com-pensation water discharged into the River Ebbw from the Lower Carno Reservoir shall be not less than 208,105 gallons per day. The Authority seeks to reduce the amount of compensation water to 58,105 gallons per day for a period of 3 months or until such time as the Lower Carno Reservoir is full whichever is the sooner.
