#### TOWN AND COUNTRY PLANNING ACT 1971

#### *Mineral Workings Act 1951*

The Secretary of State for Wales hereby gives notice that he proposes, subject to the granting of planning permission for the development hereinafter referred to, to make an Order under section 209 of the Town and Country Planning Act 1971 and section 32 of the Mineral Workings Act 1951 to authorise the temporary stopping up, for a period not exceeding nine years, of that length of highway described in the Schedule below to enable open-cast coal working to be carried out by the National Coal Board.

The proposed Order will require the restoration of the said length of road at the expiration of the period of closure.

#### *The Trunk Road (Capel Bangor, Ceredigion)* (40 mp.h. Speed Limit) Order 1975
