NOTICE OF PROPOSALS FOR VARYING A LICENCE TO ABSTRACT WATER

Notice is hereby given that the Thames Water Authority, in pursuance of section 43 of the above Act, have formulated proposals for varying Licence Serial No. 28/39/1/78 to abstract water from underground strata (Infariar Oolite) at National Grid Reference ST 938 980 in the Parish of Rodmarton, near Cirencester, Gloucestershire. The licence

authorises the abstraction of 9 million gallons per year for a private water undertaking.

The proposed variation is to include agriculture (other than spray irrigation) as an authorised purpose, to show the land on which the water may be used for this purpose and to apportion the yearly authorised quantity as follows: 5,500,000 gallons for private water undertaking and 3,500,000 gallons for agriculture (other than spray irrigation). The provisions for assessment or measurement of the quantities of water abstracted will be varied appropriately so as to relate to both purposes.

A copy of the proposals and of any map, plan or other document prepared in connection with these may be inspected free of charge at The Estate Office, Rodmarton Manor, Rodmarton, Cirencester, Gloucestershire, at all reasonable hours during the period beginning on 19th September 1975 and ending on 20th October 1975.
